**RESOLUTION AUTHORIZING SWOCA TO PROVIDE ADDITIONAL WIRELESS ACCESS  
OUTSIDE OF THE REMODELED POLICE DEPARTMENT AT A COST OF \$5,353.00.**

**WHEREAS:** The Board of Trustees has received a proposal from SWOCA to provide additional wireless access outside of the newly remodeled Police Department as set forth in the attached Exhibit "A"; and

**WHEREAS:** This will be purchased out of Safety Service Fund 2191;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby authorizes SWOCA to provide additional wireless access outside of the Police Department at a cost of \$5,353.00, plus the cost of annual service as set forth in the attached Exhibit A.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.
