

**FAIRFIELD TOWNSHIP
RESOLUTION NO. 21-17**

**RESOLUTION TO RE-APPOINT JOSEPH STATZER AS AN ALTERNATE MEMBER OF THE
FAIRFIELD TOWNSHIP BOARD OF ZONING APPEALS FOR A TERM OF ONE YEAR,
EFFECTIVE IMMEDIATELY AND EXPIRING JANUARY 31, 2022.**

WHEREAS: Joseph Statzer has served on the Fairfield Township Zoning Appeals Board and his term expires January 31, 2021; and

WHEREAS: The Board of Trustees desires to re-appoint Joseph Statzer as a member of the Fairfield Township Zoning Appeals Board;

NOW, THEREFORE, BE IT RESOLVED, by the Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board of Trustees hereby re-appoints Joseph Statzer as a member of the Fairfield Township Zoning Appeals Board for a five-year term, effective immediately and expiring January 31, 2022, in accordance with the terms of the Fairfield Township Board of Zoning Appeals established in section 330 of the Zoning Resolution of Fairfield Township.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and do authorize the adoption of this resolution upon its first reading.

SECTION 3: This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
