RESOLUTION NO. 21-18**

**RESOLUTION TO APPROVE THE REPAIR OF FORD INTERCEPTOR
FOR THE POLICE DEPARTMENT AT A TOTAL COST OF \$6,974.05.**

WHEREAS: The cost to repair the vehicle at Liberty Collision is \$6,974.05 and will be taken from Fund #2191; and

WHEREAS: Fairfield Township received checks from insurance made payable to Fairfield Township for the vehicle repair in the amount of \$6,849.05 and insurance will pay Liberty Collision any supplemental difference hereafter;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the repair of the Ford Interceptor for the Police Department at a total cost of \$6,974.05. Insurance paid \$6,849.05 for the repair, attached hereto as Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.




