RESOLUTION NO. 21-63

**RESOLUTION REQUESTING THE COUNTY AUDITOR TO MAKE ADVANCE PAYMENTS
OF TAXES PURSUANT TO OHIO REVISED CODE 321.34.**

WHEREAS: The Ohio Revised Code allows a taxing authority to request payment from the County Auditor funds derived from taxes or other sources to the County Treasurer, which may be held on account of a local subdivision; and

WHEREAS: The Board hereby authorizes the Auditor and the Treasurer of Butler County in accordance with the Ohio Revised Code 321.34, be requested to draw and pay to Fairfield Township upon the written request of Shelly Schultz, Fiscal Officer, to the County Auditor, for legal and appropriate funds due in the second half settlement for 2020 derived from taxes or other sources, payable to the County Treasurer to the account of Fairfield Township and lawfully applicable for purposes of the current fiscal year; and

WHEREAS: The Fairfield Township Fiscal Officer shall forward to the County Auditor a certified copy of this Resolution;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the County Auditor to make advance payments of taxes pursuant to Ohio Revised Code 321.34.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
