RESOLUTION AUTHORIZING THE ADMINISTRATOR TO APPLY FOR THE CDBG-CV PROGRAM GRANT IN THE AMOUNT OF \$160,000.00 FOR THE MILTON ROAD PARK PROJECT.

WHEREAS: The CDBG-CV Funds are to be used to address needs caused by this COVID-19 virus with the requirement that projects must prepare, prevent, or respond to the COVID-19 pandemic; and

WHEREAS: The park would serve a low- or moderate-income area and provide outdoor fitness opportunities and social space to residents in the area where COVID-19 transmission is less likely; and

WHEREAS: Estimates for the proposed project came in at the cost of \$176,000.00 and Fairfield Township has agreed to match any Grant awards with a 10% match;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board hereby authorizes the Administrator to apply for the CDBG-CV Grant for the Milton Road park project.
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- **SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.


