## FAIRFIELD TOWNSHIP RESOLUTION NO. 21-91

RESOLUTION FOR DISPOSAL BY PUBLIC SALE OF EQUIPMENT (VALUE GREATER THAN \$2,500.00) WHICH IS OBSOLETE, UNFIT, OR UNNEEDED FOR PUBLIC USE (O.R.C. SECTION 505.10).

**WHEREAS:** Ohio Revised Code Sec. 505.10 authorizes the Board of Trustees to dispose of personal property, equipment, and tools, which the Board finds by resolution are not needed for public use, or are obsolete, or are unfit; and

**WHEREAS:** The Board of Trustees authorizes the Fire Chief to sell to Butler EMA the 2013 Suburban for \$8,000.00;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board OF Trustees finds that, in the opinion of the Board, the following vehicle is not needed for public use, or is obsolete, or unfit for use by Fairfield Township and has a reasonable value of \$8,000.00.
  - Fire Department 2013 Suburban VIN 1GNWKLEGODR138884
- SECTION 2: Pursuant to O.R.C. Section 505.10 (A)(1), the Board finds that, in the opinion of the Board, the value of the property exceeds \$2,500 and directs the sale of the above vehicle to Butler EMA at a total cost of \$8,000.00.
- **SECTION 3:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorized the adoption of this resolution upon its first reading.
- SECTION 4: This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 5: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 6:** This resolution shall take effect at the earliest period allowed by law.
