RESOLUTION TO AUTHORIZE DEBT SERVICE PAYMENT OF \$264,775.00 TO US BANK FOR THE VARIOUS PURPOSE GENERAL OBLIGATION REFUNDING BONDS FOR THE EAST SIDE OF PRINCETON ROAD.

WHEREAS: Payment in the amount of \$264,775.00 is due for various purpose General Obligation Refunding Bonds related to the District Highway Improvement Bond for the East side of Princeton Road; and

WHEREAS: Principal amount due is \$235,000.00 and Interest is \$29,775.00; and

WHEREAS: This Debt Service Payment will be taken out of Fund No. 2906;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby authorizes the Debt Service Payment of \$264,775.00 due on December 1, 2022, to US Bank for various purpose general obligation refunding bonds for the East Side of Princeton Road, attached hereto as Attachment "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
