**RESOLUTION AUTHORIZING THE ADMINISTRATOR TO EXECUTE A SALT CONTRACT
WITH THE BUTLER COUNTY ENGINEER'S OFFICE FOR THE
2021 & 2022 SNOW & ICE CONTROL SEASON.**

WHEREAS: Fairfield Township annually enters into an agreement for the purchase of road salt through the Butler County Engineer's Office; and

WHEREAS: The Butler County Engineer's Office meets all applicable State and local requirements through its bid process for road salt; and

WHEREAS: A copy of the salt contract has been attached and made a part of this resolution by reference.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the Administrator to execute the agreement to participate with the Butler County Engineer's Office for the bidding and purchasing of road salt for the 2021 & 2022 snow & ice control season which will be \$76.29 per/ton for dump, attached hereto as Exhibit "A" and will be taken from Fund numbers 2231, 2021, 2031 & 2011.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.




