RESOLUTION NO. 22-24**

**RESOLUTION AUTHORIZING THE ADMINISTRATOR TO EXECUTE A BRINE MIXTURE
CONTRACT WITH THE BUTLER COUNTY ENGINEER'S OFFICE FOR THE
2021 & 2022 SNOW & ICE CONTROL SEASON.**

WHEREAS: Fairfield Township annually purchases Brine Mixture through the Butler County Engineer's Office; and

WHEREAS: The Butler County Engineer's Office has requested a resolution for the Brine Mixture;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the Administrator to execute the agreement with the Butler County Engineer's Office for the purchasing of brine mixture for the 2021 & 2022 Snow & Ice Control Season at a cost of .31 center per gallon and will be taken from Fund numbers 2231, 2021, 2031 & 2011.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.




