**RESOLUTION TO APPROVE PURCHASE OF BICYCLES FROM VOLCANIC BIKES  
FOR THE POLICE DEPARTMENT IN THE TOTAL AMOUNT OF \$8,534.56.**

**WHEREAS:** The Police Chief has recommended the purchase of bicycles for the health, safety, and welfare of the residents of Fairfield Township; and

**WHEREAS:** As the Township increases staffing, it will be training a core of officers that can ride bikes during special events and address community concerns related to crime and disorder; and

**NOW, THEREFORE, BE IT RESOLVED,** by the Trustees of Fairfield Township, Butler County, Ohio, as follows:

**SECTION 1:** The Board of Trustees hereby approves the purchase of bicycles from Volcanic Bikes, for the Police Department in the total amount of \$8,534.56, to be paid out of Fund 2081, as included herein on Attachment "A".

**SECTION 2:** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.


