**RESOLUTION APPROVING THE PURCHASE OF A STRYKER POWERLOAD AMBULANCE  
COT AND POWER LOAD SYSTEM FOR THE FIRE DEPARTMENT FROM STRYKER IN THE  
AMOUNT OF \$49,764.58.**

**WHEREAS:** The Fire Dept has Power Cots, Power Load Systems in our ambulances to provide for safer transport and loading of patients; and

**WHEREAS:** The Fire Department is purchasing another ambulance and will need to equip it properly; and

**WHEREAS:** The purchase will be paid from the EMS Fund No. 2281;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby approves the Purchase from Stryker in the amount of \$49,764.58, to be paid from EMS Fund 2281 as set forth on the attached Exhibit "A".

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.






