**RESOLUTION TO AUTHORIZE A THEN AND NOW PURCHASE ORDER FOR ANNUAL
MAINTENANCE ON RADIOS FROM THE BUTLER COUNTY SHERIFF'S OFFICE
AT A PRICE NOT TO EXCEED \$4000.00.**

WHEREAS: Fairfield Township annually enters into an agreement for maintenance of radios for the Police, Fire and Public Works Departments; and

WHEREAS: Money was appropriated for 2022, prior year invoice came in July, so purchase order was set to be opened in June; and

WHEREAS: Butler County Sheriff's Office sent the invoices in February this year;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the payment of the attached invoices from Butler County Sheriff's Office, for annual maintenance on radios for the Police, Fire and Public Works Departments. This will be paid out of Fund Numbers 2081, 2111 & 2021.

SECTION 2: The Board hereby dispenses with the requirement that this Resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this Resolution upon its first reading.

SECTION 3 This Resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This Resolution shall take effect at the earliest period allowed by law.
