**RESOLUTION TO APPROVE PURCHASE OF MOWING EQUIPMENT FROM FAIRFIELD
POWER EQUIPMENT FOR THE TOWNSHIP PUBLIC WORKS DEPARTMENT
IN THE TOTAL AMOUNT OF \$15,059.00.**


WHEREAS: The Public Works Supervisor has recommended the purchase of a new mower; and
WHEREAS: Fairfield Power Equipment has offered better than State Bid pricing for the equipment; and
WHEREAS: This will be used to maintain our Administration buildings and Parks;
NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1:** The Board hereby authorizes purchase of new mowing equipment, in the amount not to exceed \$15,059.00, from Fairfield Power Equipment, attached hereto as Exhibit "A". This will be purchased out of Fund No. 1000.
- SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- SECTION 5:** This resolution shall take effect at the earliest period allowed by law.





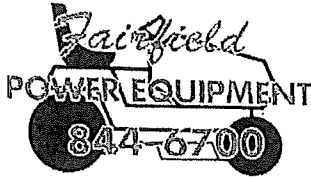
