**RESOLUTION AUTHORIZING FIRE CHIEF TO EXECUTE AGREEMENT WITH BUTLER  
TECH DONATING 2013 HORTON AMBULANCE IN EXCHANGE  
FOR TRAINING SERVICES.**

**WHEREAS:** This agreement between Fairfield Township Board of Trustees and Butler Tech is intended as a sale of equipment in exchange for training resources having equal value; and

**WHEREAS:** The Township shall transfer to Butler Tech for its use in the school fire education program a 2013 Horton Ambulance, in "As Is Condition"; and

**WHEREAS:** Butler Tech in return will allow the Fairfield Township Fire Department to send individuals to training located at 5140 Princeton Glendale Road, Liberty Township, OH 45011. Training will consist of tuition only and does not cover the cost of books or associated fees.

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** That the Board authorizes the Administrator to execute the agreement with Butler Tech.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

This agreement between the Fairfield Township Fire Department and Butler Tech and Career Development Schools is intended to provide for the even trade of equipment for training tuition. The Fairfield Township Fire Department, as part of its vehicle replacement schedule, will provide a 2013 Horton Ambulance- VIN # 1GB6G5CLOD1145925 to the Public Safety Education programs operated by Butler Tech. In return, the Public Safety Education programs will allow the Fairfield Township Fire Department to send individuals to training located at 5140 Princeton Glendale Rd, Liberty Township, OH 45011. Training will consist of tuition only and does not cover the cost of books or associated fees. All training conducted for the Fairfield Township Fire Department on Butler Tech grounds shall be scheduled in advance. The following prices are in effect July 1, 2022. The length of this contract will last for 36 months from the date of execution or until \$20,000 of tuition has been exhausted, whichever occurs earlier.

Tuition and fees are as follows:

1. Firefighter Rescue Academy-Daytime
  - a. Tuition: \$6000.00
  - b. Books/Fees: \$3295.00
  
2. Firefighter Rescue Academy-Evening
  - a. Tuition: \$6000.00
  - b. Books/Fees: \$3295.00

3. Firefighter Level I & II- Daytime
  - a. Tuition: \$3000.00
  - b. Books/Fees: \$2271.00
  
4. Firefighter Level I & II-Evening
  - a. Tuition: \$3000.00
  - b. Books/Fees: \$2271.00
  
5. EMT-Basic
  - a. Tuition: \$1200.00
  - b. Fees: \$203.00
  
6. Paramedic
  - a. Tuition: \$8800
  - b. Fees: \$1200

Total Value of Training: \$20,000.00 over the course of the contract.

As part of this agreement the Fairfield Township Fire Department agrees to hold Butler Tech free from liability for personal injury of Fairfield Township Fire Department personnel while training on property owned and managed by Butler Tech. Additionally, the Fairfield Township Fire Department agrees that all training conducted at Butler Tech will be done under the supervision of certified Instructors from Butler Tech.

Representatives of Butler Tech have inspected the vehicle and have determined its suitability for the intended use. The vehicle is accepted in "AS IS" condition. The Township disclaims any express or implied warranties regarding the operating condition and serviceability of the equipment specifically including suitability of intended purpose and merchantability.

IN WITNESS WHEREOF, the authorized representatives of the parties have each set their hand hereunder in order to signify their intent to be bound by the foregoing.
