**RESOLUTION TO AUTHORIZE A THEN AND NOW PURCHASE ORDER FOR PARAMEDIC TUITION FOR FIREFIGHTER/EMT JOSHUA LENTZ AT A TOTAL COST OF \$5,190.00.**

**WHEREAS:** Fairfield Township Trustees approved Paramedic Tuition for Joshua Lentz per attached Resolution 19-101 dated August 14, 2019 at a total cost of \$9,151.00; and

**WHEREAS:** Butler Tech invoiced \$3,961.00 in August 2019, which was paid to Butler Tech on August 27, 2019; and

**WHEREAS:** Butler Tech notified the Fiscal Office of an outstanding balance due on June 3, 2022;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby authorizes the payment of the attached invoice from Butler Tech, at a total cost of \$5,191.00. This will be paid out of Fund Number 2281.

**SECTION 2:** The Board hereby dispenses with the requirement that this Resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this Resolution upon its first reading.

**SECTION 3** This Resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.


**SECTION 5:** This Resolution shall take effect at the earliest period allowed by law.




