RESOLUTION NO. 23-119**

**RESOLUTION APPROVING ACCEPTANCE OF EMA ARPA RETENTION/INCENTIVE
PROGRAM GRANT IN THE AMOUNT OF \$110,112.**

WHEREAS: The Fire Department was awarded a Grant through the EMA ARPA Peer Support Program in the amount of \$110,112; and

WHEREAS: This State Grant is intended to provide a one-time Retention/Incentive Bonus to First Responders based on operations during COVID 19 by Fairfield Township Fire Department Staff in 2022; and

WHEREAS: These payments are to be made to the Fire Department staff as set forth on Attachment A;

NOW, THEREFORE, BE IT RESOLVED, by the Trustees of Fairfield Township, Butler County, Ohio, as follows:

SECTION 1: The Board of Trustees hereby accepts the above-described Grant in the amount of \$110,112 and approves the payments as set forth on Attachment A.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3: This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.




