RESOLUTION TO AMEND THE 2023 PERMANENT APPROPRIATIONS.

WHEREAS: The Board desires to amend 2023 permanent appropriations;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the amendment to the 2023 Permanent Appropriations, as listed on the attached Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.



SECTION 5: This resolution shall take effect at the earliest period allowed by law.






