**RESOLUTION TO APPROVE PURCHASE OF 2022 FORD F-350 FROM CRONIN FORD  
FOR THE PUBLIC WORKS DEPARTMENT IN THE AMOUNT OF \$46,887.00.**

**WHEREAS:** A need has been determined for a service vehicle in the Public Works Department to replace the 2009 F-350 sold last year; and

**WHEREAS:** The vehicle will be used for daily operations and towing;

**NOW, THEREFORE, BE IT RESOLVED,** by the Trustees of Fairfield Township, Butler County, Ohio, as follows:

**SECTION 1:** The Board of Trustees hereby approves the purchase of 2022 Ford F-350 for the Public Works Department in the total amount of \$46,887.00, to be paid out of Fund 2272, from Cronin Ford, as set forth on the attached Exhibit A.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.




