**RESOLUTION APPROVING THE 2023 ANNUAL INVOICE PAYMENT IN THE AMOUNT OF \$14,760.00 TO MIAMI VALLEY REGIONAL CRIME LABORATORY.**

**WHEREAS:** The Miami Valley Crime Lab provides laboratory services and is used by the Police Department for crime scene investigation and analysis; and

**WHEREAS:** This will be paid out of Fund No. 2191; and

**WHEREAS:** The yearly price has been increased due to rising costs of new equipment required to test Marijuana and increase staffing to keep up with the demand.

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby approves the 2023 annual invoice payment in the amount of \$14,760.00 to Miami Valley Regional Crime Laboratory, attached hereto to as Exhibit "A".

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.


