- **SECTION 1:** The Board hereby approves replacing the water line at Heroes Park by Curry & Sons Construction Company, at a total cost of \$35,000.00.
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3: This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

Estimate Details

Install a new 2" waterline from the meter pit to the concession building. Process of this installation is to jack hammer a concrete block at the building where the copper waterline and plastic line transition underground. Excavate a hole 40 feet in the yard from the building. Directional bore underground to the concession stand and pull in a copper line underground to the hole 40 feet from the building. This eliminates all plastic underground of the concession stand. Install 560 feet of Plastic PE pipe from the meter pit underground to the copper line stubbed out from the building. Process of this installation is to excavate down at the meter pit by the road, and 300 feet from from the building. Directional bore underground to the hole with the new copper and pull back new 2" PE line to the 2nd hole 300 feet away. Then directional bore from the meter pit to the hole 300 feet away and continue pulling back the 2" line in one continuous run. Tie the new 2" waterline into the meter pit, and tie it into the concession building. Backfill snoils at the meter pit and holes in the run. Tie the new 2" waterline into the meter pit, and tie it into the concession building. Backfill spoils at the meter pit and holes in the yard and restorate the yard back, pour concrete back into the hole at the patio at the concession building.
