RESOLUTION AUTHORIZING A THEN AND NOW PURCHASE ORDER FOR JUNK KING CINCINNATI AT A PRICE NOT TO EXCEED \$5,525.00.

WHEREAS: Dumpsters were needed for Spring cleanup day 2023;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the payment of the attached invoice from Junk King Cincinnati in the amount of \$5,525.00 for a total of 13 dumpsters used at the Spring Clean up event on April 29, 2023. This will be paid out of Fund No. 1000.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
