RESOLUTION AUTHORIZING THE PURCHASE OF PLAYGROUND EQUIPMENT FOR THE MILTON STREET PARK FROM GAMETIME COMPANY AT A COST NOT TO EXCEED \$122,000.00.

WHEREAS: The Board of Trustees recommends adding updated playground equipment for ages 2-5 to the Milton Street park; and

WHEREAS: The Board of Trustees were awarded \$150,000.00 of Butler County's ARPA/SLFR fundings (Resolution 24-99) for Milton Street playground improvements; and

WHEREAS: GameTime is a member of the Omnia Partners Purchasing Cooperative, and offers discounted rates for select equipment purchased off-season;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows:

- SECTION 1: The Board hereby authorizes the purchase of playground equipment for ages 2-5 From GameTime Company at a cost not to exceed \$122,000.00.
- SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

2024 Matching Funds Playground Grant Terms:

The above contract allowance is available through GameTime's "2024 Playground Grant" program and represents a 80% Matching Fund Grant for the play structure/s quoted. The 80% Matching Funds are contingent upon supplying payment (check or cash or ACH) for the equipment at the time the order is placed. Inability to provide payment will result in 65% Matching Funds in lieu of the 80% Matching Funds.

This grant is only valid for GameTime Modular or Pre-Designed play structures in the PowerScape, PrimeTime, IONiX and Xscape, Modern City, Towers, KidCourse, Thrive, Challenge Course, and the Stadium product lines.
