**RESOLUTION APPOINTING JASON AUSTERMAN AS A MEMBER OF THE FAIRFIELD  
TOWNSHIP ZONING COMMISSION TO FILL THE VACANT, UNEXPIRED TERM  
WHICH EXPIRES JANUARY 31, 2025.**

**WHEREAS:** A vacancy exists on the Zoning Commission; and

**WHEREAS:** The Board of Trustees desires to appoint Jason Austerman to replace Michael Jodrey as a member of the Fairfield Township Zoning Commission;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby appoints Fairfield Township resident Jason Austerman to replace Michael Jodrey as a member of the Fairfield Township Zoning Commission, effective immediately and expiring January 31, 2025, in accordance with the terms outlined in section 320 of the Zoning Resolution of Fairfield Township.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.




