**RESOLUTION TO AUTHORIZE SALARY INCREASES FOR THE NON-UNION
EMPLOYEES.**

WHEREAS: The Board has determined pay raises for employees as listed on the attached Exhibit "A"; and

WHEREAS: Raises will be effective for the first full pay period after the effective dates listed on Exhibit "A";

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board approves employee raises as listed on the Exhibit "A" for the first full pay period after the effective dates listed on Exhibit "A". For probationary employees raises will be effective the first full pay period after their probation period.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.


