

**FAIRFIELD TOWNSHIP
RESOLUTION NO. 25-48**

**RESOLUTION AUTHORIZING THE PAYMENT OF FUNDS TO JOHN R. JERGENSEN FOR
THE 2025 PAVING PROGRAM IN THE AMOUNT OF \$834,623.14
FROM THE RID FUND 4903.**

WHEREAS: Butler County can receive a discount on paving roadways within the County; and

WHEREAS: Butler County has provided Fairfield Township with an estimate for work on Fairfield Township roads based on desired 2025 work, with said estimate subject to change upon selection of bid by Butler County; and

WHEREAS: The Butler County Engineer's Office bid out the county and the township's paving list for 2025 and has awarded the contract to John R. Jergensen in the amount of \$834,623.14; and

WHEREAS: Funds will be paid directly to John R. Jergensen; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the payment of funds to John R. Jergensen for the 2025 Paving Program in the amount of \$834,623.14 and will be paid from the RID Fund 4903.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.




