RESOLUTION NO. 26-09

RESOLUTION AUTHORIZING CLOUD MEMBERSHIP.

WHEREAS: Section 505.241 of the Ohio Revised Code grants the authority to a board of township trustees to authorize its elected officers to join an association or nonprofit organization formed for the improvement of township government; and **\$200**

WHEREAS: Section 505.241 of the Ohio Revised Code further grants the authority to a board of trustees to appropriate from its general fund an amount sufficient to pay the dues, subscription costs, or membership charges of such association or non-profit organization; and

WHEREAS: The Coalition of Large Urban Townships (hereinafter referred to as CLOUD), which is part of the Ohio Township Association, qualifies as an association or non-profit organization formed for the improvement of township government within the meaning of Section 505.241 of the Ohio Revised Code; and

WHEREAS: Fairfield Township is eligible to be a member of CLOUD based on its population in the unincorporated area of 25,000 and/or a budget of over \$10,000,000.00; and

WHEREAS: The board desires to participate as members of CLOUD.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: Fairfield Township Trustees hereby authorizes Fairfield Township, Butler County, Ohio to become a member of CLOUD, as part of the Ohio Township Association, and to pay the annual CLOUD membership dues for 2026.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.




SECTION 5: This resolution shall take effect at the earliest period allowed by law.
