#### ADMINISTRATOR'S REPORT

**Mrs. Vonderhaar** – I've been happy with the progress we've seen with the progress of our team with keeping operations going. We had already prepared with cross-training in each department. We have already established remote options. There are some concerns how everything could impact the township. I did look at a few things like the JEDD and Local Government funds. I assumed worst case if local government dries up, we could lose \$376,000 that we receive. So, there is a potential of \$700,000. The last thing I took into account is our gasoline tax and took 15% - 20% off this tax. I'm coming up with a \$500,000 - \$700,000 hit that we could see. We were well prepared with supplies from

the last crisis, I think was Ebola. There are no red flags at this time.

**Mr. McAbee** – I would say 20% is on the low side. It could be a \$1,000,000. It could take a long time for this to come back. This is a big financial crisis. Foreclosures could be up. Is staffing ok?

**Mrs. Vonderhaar** – we have everyone working. I'm in contact daily with every department.
