Old Business/Items for Board Discussion

• Community Garden – 1884 Harvard Street

Maria Tangy, 1891 Harvard Street – I'm interested in putting a community garden at that lot. I've talked to a couple neighbors, and they are interested in being a part of the core committee. I've put together a little diagram of how the garden would look. I've talked to Chuck about zoning things. We saw that a parking area might be needed.

Mrs. Berding – I like the plan.

Mrs. Vonderhaar – My questions would be who would run this, how would it be maintained, who would fund it.

Ms. Tangy – Some of the things Chuck and I discussed was the Township maybe helping and putting fencing up around front section and helping to clear out the overgrowth. There is potentially a place we could put in water. Also, we need to find out if there are any existing foundations. I have people willing to financially fund me; just donation wise and people putting their time in. I would just be in charge of making sure it happened.

Mrs. Hartkemeyer – Mr. Barbiere from a liability perspective what would we need to take into consideration.

Mr. Barbiere, Law Director – I don't think it would be a real risk from a liability standpoint. It would be covered by CIC insurance. It doesn't seem like the undertaking that would have a whole lot of liability involved.

Mrs. Berding - We could consider it a park of sorts; couldn't we?

Mr. Barbiere, Law Director - If we considered it a park it would be recreational immunity with less liability. I wouldn't be too concerned from a liability standpoint.

Ms. Tangy - Originally, we were talking about considering this for a year to see how it goes. This is why I would recommend you doing the fencing. Any permanent structure would still be your property.

Mrs. Vonderhaar – How quickly would you want to get started?

Ms. Tangy – The sooner we can get started in doing some prep work before winter starts would be nice and start promoting it to get the funding before spring.

Mr. McAbee – It sounds pretty good to me.

Ms. Tangy - Also Chuck said maybe we could get some help from some bigger companies in building the shed such as Home Depot or Menards.

Mr. McAbee - Are we going to need some type of contract?

Mr. Barbiere, Law Director – I think something in writing maybe a lease or something along those lines.

Mrs. Hartkemeyer - So we need some type of legal mechanism in place to get this started.

Mr. Barbiere, Law Director – Yes, do you want me to put that together?

Mrs. Berding – Yes, please.

Mrs. Berding - In terms of next steps we would meet again to approve and sign the lease.

Ms. Tangy – Thank you so much.

Mrs. Berding – Thank you for the wonderful idea.

We already have the money and its in the bank and I understand it at this point I think the easiest way to complete the transaction is to just accept it and do a resolution. I think legally it can be done either way.

RESOLUTION AUTHORIZING THE TRANSFER OF \$100,000.00 FROM THE FAIRFIELD TOWNSHIP BUTLER COUNTY COMMUNITY IMPROVEMENT CORPORATION TO THE GENERAL FUND 1000.

WHEREAS: \$100,000.00 was received from the Butler County Land Bank payable to the CIC and deposited into the CIC bank account; and

WHEREAS: Resolution #16-105 dated 10-12-2016 allowed \$200,000.00 to be deposited to the Butler County Land Reutilization Corporation from the Fairfield Township General Fund 1000; and

WHEREAS: Purchase Order #211-2016 dated 10-13-2016 was issued to Butler County Land Reutilization Corporation for the \$200,000.00 payment;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby authorizes the transfer of \$100,000.00 from the CIC Board to the General Fund 1000.
- SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- SECTION 4: This resolution shall take effect at the earliest period allowed by law.
