- 4. Fairfield Township Police Department
- 5. Fairfield Township Service/Road Department

Nothing contained in this section shall prevent the addition, deletion, or modification of the designed and specified Purchasing Card accounts by the Fairfield Township Fiscal Officer of his/her designee.

If multiple cards are required for each Department, the Department Head may request additional Purchasing Cards, which may be approved at the discretion of the Fiscal Officer. Duplicate cards shall be maintained in the same manner as described in Section 4.0 of this policy.

Zoning Department - Chuck Goins, I believe you all have my report. In addition to that we do have a zoning commission meeting scheduled for tomorrow evening at 7 pm here to hear Zoning Case FTZC20-1C. This is a zone change at a portion of the Bridgewater Church. The Commission is going to be hearing the amendments to the Fairfield Township zoning resolution. Next week we have a zoning appeals board meeting. We do have a few businesses that are about to be open. They've expressed an interest in having events. Urban Air Trampoline & Adventure Park they are scheduled for ribbon cutting on February 28th at 4 pm they would like the trustees to attend, if you are available McAllister's also has a ribbon cutting event March 2nd at 10 am.
