Dear Nancy:

This is to advise that an ACH payment in the amount of \$41,005.68 in payment of Fairfield Township's February, 2017 net collections for the J.E.D.D. I and II will be forthcoming. This is in accordance with the J.E.D.D. Board Directive September 1, 2005 to have the distributions made monthly.

For the calculations pertaining to the balance for distribution of funds for Feb, 2017 we now have the original J.E.D.D. (categorized as J.E.D.D. I) and the first amendment adding area to the original J.E.D.D. (categorized as J.E.D.D. II). The total available for distribution (net of the refund escrow and the commission fee) for February, 2017 for J.E.D.D. I is \$46,317.89 (See J.E.D.D. I collections attachment). The J.E.D.D. agreement determined that the distributions for J.E.D.D. I will be paid 75% to the City of Hamilton and 25% to Fairfield Township. The distribution according to that criteria would result in a payment of \$34,738.42 to the City of Hamilton and a payment of \$11,579.47 to Fairfield Township.

The total available for distribution (net of the refund escrow and the commission fee) for February, 2017 for J.E.D.D. II is \$39,234.95 (see J.E.D.D. II collections attachment). The J.E.D.D. agreement determined that the distribution for J.E.D.D. II will be paid 25% to the City of Hamilton and 75% to Fairfield Township. The distribution according to that criteria would result in a payment of \$9,808.74 to the City of Hamilton and a payment of \$29,426.21 to Fairfield Township.

The total combined amount due to the City of Hamilton is \$44,547.16. The total combined amount due to Fairfield Township is \$41,005.68.
