I'm really here to ask that the Board to consider an amendment for the Fairfield Township Joint Economic Development District #1. This was contemplated when the Board passed the original JEDD agreement April 2022. The two parcels that are in question that would be added to the JEDD district #1 have now been acquired by the developer as part of the arrangement. The agreement was when they acquired those parcels that they would agree to have those entered into the JEDD agreement and, thus, creating more revenue for the Township and the City of Fairfield. They have fulfilled that obligation and they are ready to proceed with that. If the Board would so move, we could establish a public hearing on the 14<sup>th</sup> of February. All terms and conditions would be the same to the existing agreement. We will have the petitions executed. Hopefully by the end of the week we will have the final amendment.

**Mr. McAbee** - This takes care of everything except the piece that fronts on Tylersville? **Mr. Geis** – Yes. These are all the parcels that were contemplated on the original agreement.

### ITEMS FOR BOARD DISCUSSION

Mrs. Hartkemeyer - There is a phone number to call that you can discontinue the newspapers that is thrown in your driveways each week. This is a live person, and you leave your address. That number is 513/731-1200. You can also go to <a href="https://www.save.com">https://www.save.com</a> and enter your information and they will take you off the delivery list. They did say it would take about 6 weeks to be removed from list.

Assistant Law Director Lawrence E. Barbiere – I did some research and governments that have tried to pass ordinances or resolutions to try and stop people from handing out these unwanted newspapers as long as they are throwing them from public property onto a driveway that can be struck down due to the First Amendment. A homeowner can stop someone from coming up and knocking on their door or putting it inside a screened door. It would probably be unconstitutional for a township to pass a law to stop a mailer

in someone's driveway because it would be a violation of the First Amendment.

On Monday we had some key members of our staff come in went through a brainstorming process. You have each been emailed a copy of that. These are the results of the comments we had. What I suggest we do as a Board is take a look at this read through them and think about what we individually like and then also think what is maybe not on the lists. At the next meeting we can discuss what we see and how we should move forward.

**Mr. Berding** – If you could provide who all as involved and the departments they are in. What do the individual numbers mean that are in parenthesis behind the comments? **Mrs. Hartkemeyer** – The numbers are the votes. Everyone was given a sharpie, yellow sticky pads and 6 blue dots and everyone was asked to brainstorm as many ideas as they could and 10-15 minutes on where Fairfield Township is going across the board. One person at a time would read their ideas and I would put them on the wall and we went around and everyone read an idea. Then we silently sorted them into categories. We were looking for things that had relationships with each other. The last stage of the process was they are action ordinated. This is more to identify the trends. This is a feedback mechanism for the Board from the leadership team and staff as well. It's also important to know that the staff is comprised of a lot of people that live in the Township.
