Ms. Schultz - Just as in previous years I've estimated the revenue on what we've received in the first half in the property taxes and then had to estimate 2nd half which is about 85% of what we received in the first half. Then for other revenue I estimated that based on the first 6 months of revenue. I did not assume we were getting anything in gasoline tax, just to be conservative. I did not assume we were getting anything in 2nd half for JEDD, just to be conservative. Even though we did receive a small amount in TIF for Millikin Road I assumed zero again since Millikin Road is complete. As far as appropriations I took the first 6 months of expenses and analyzed those out and rounded and estimated based on that. As far as estimating year end fund balances I looked at each balance where we were and what was encumbered and what was going to be our year-end balance and did the best I could with estimating that. It looks very similar to last year. It was a very conservative approach, as always. I feel like with what information we currently have it's the best numbers that I have.
