Mrs. Vonderhaar – Renewal 2% increase with Humana. That does include a no-shop. Total cost to the Township will be \$18,315. Employee participation is 5%. This year we've recouped almost \$28,000 in the wellness program. Last year we ended up with almost \$36,000. Dental and vision has a 2-year rate guarantee.

Mrs. Hartkemeyer – I'm encouraging everyone to participate in Go365. This will greatly reduce our cost.

Mr. McAbee – How many families do we have on this plan? We need to find additional ways for cost sharing.

Mrs. Vonderhaar – Roughly 57. We have started a wellness and safety committee to encourage our employees.

• Admin intern for the summer

Mrs. Vonderhaar – Olivia Gilliand. She is a resident of Fairfield Township. She will be a senior at Northwest. She is interested in political science and communications. She would be working 15 -20 hours per week. I could have her work on website with events and we're going digital on a lot of our zoning. We have plenty she could work on. I think it would be great working on social media flyers.

Mrs. Hartkemeyer – One of the things I would be interested in learning more about is how we can encourage young people on taking careers as first responders. I'd like to see some research on that.

I will have a meeting with the department heads to see what we can offer. There is probably 7 or 8 months we could work with them. We could make it practical for the staff.

• Morris Road property

Mrs. Vonderhaar – Last month, you came in; Sean and Andrea Carlock, since that time we've been in contact, and I've been advised several times when it rains. We've all came out and looked and taken pictures. This situation that this homeowner is in is that they are in a detention pond. There is a detention pond behind them. Everything that has been built on that property is working as it should. However, its inundating their property and sometimes compromising the road. I think there is 100 acres of waterflow. I would offer to the Board if we could hire an engineering firm and do some kind of study to see what we could do and what would the cost be. I'm not saying the Township should absorb the cost but at least the homeowners could find some kind of answers.

Mrs. Hartkemeyer - We can get some quotes for that and discuss at the next meeting. **Mr. McAbee** – Mrs. Vonderhaar can you contact the HOA?

Mrs. Vonderhaar – Yes.

Mr. Barbiere, Law Director - I would think the county has some jurisdiction over drainage issues.

Mrs. Vonderhaar – I did write letters of commendation for Chief Chabali and Captain Lanier for leadership displayed on May 26, 2022 and that passes on to their team as well.
