ITEMS FOR BOARD DISCUSSION

• Conversion of payroll software – Fiscal Officer

Ms. Schultz – You have all gotten a packet from ADP. I am asking for permission to change from our current payroll software to ADP. Since I've been in office, I personally, haven't been happy with Paycor and their customer service or their software. We've been with them approximately 5 years. Cost wise, last year, we paid Paycor \$23,000. The cost for ADP came in at \$19,000. I know the cost savings is not significant. I'm not changing for this reason. I've worked with ADP in the past and have had great success. I believe it would be a very good move for our department as far as reporting. Since being in the office there has been many times when I've needed to run a report for a department manger and Paycor has not been able to handle that for me. I can't even run reports for myself with their software. Its not user friendly. The 2 girls in my office feel the same way. Personally, I don't think it was set up correctly initially. I would like permission to make this move. It will not cost the Township any extra

money and will probably save money. No one in the Township will notice a change. All the W-2's will still be one. All the tax information will be loaded into ADP. The lead time will be about 4 - 6 weeks. I will lead the project with my office. I do have an agreement here. A move cannot be made until 2 payrolls in a quarter have been made. **Motion** made by Mrs. Berding, second by Mrs. Hartkemeyer to allow Fiscal Officer to sign a contract with ADP contingent upon Mr. Barbieri's approval of contract language. YES – Mrs. Hartkemeyer, Mr. McAbee, Mrs. Berding

• Fairfield Township Grocery Shopping

Mrs. Hartkemeyer – At the last meeting this was brought up. There were concerns about our fire staff shopping at grocery stores outside of Fairfield Township. There was discussion about that, and we asked them only to shop at Target and Wal-Mart. However, since then it has been brought to my attention that there are some potential issues with that. The Fire Department had some concern that Wal-Mart had some kind of meat recall, so they were not particularly comfortable shopping there. They were somewhat concerned about shopping at Target for those products. Technically, we don't have a full-size Myers's or Kroger's in Fairfield Township at this time. They do more cooking than carryout. They wanted us to have a little bit more discussion on this. **Mrs. Berding** - I think using the Kroger's on Liberty-Fairfield is fine. I think it is important to support Fairfield Township businesses but at the same time not to restrict our Fire Department.

Mr. McAbee - Not long ago I was on Grand coming this way and saw the squad. I think it's too big a risk to take to be over there when a call comes in. Especially if a train is coming. Do they go daily?

Mrs. Vonderhaar - The shifts change daily. My understanding after talking to the Assistant Chief they plan on using the Liberty-Fairfield Road Kroger's. My guess with Hamilton was they were doing some type of training or mutual aid. I know we are making our runs doing their jobs and they use excellent judgement.

Mr. McAbee - It's a major concern if a train is coming and they are setting in Hamilton. The folks at Five-Points are totally unprotected.

Mrs. Hartkemeyer – I don't have a problem if they take a quick trip. I'm a little concerned if they are at the Hamilton Kroger's and being on the other side of the train track. I think, as professionals, they can handle their choices on where to handle their food. And, I would expect them to handle it promptly and appropriately.

• Playground Update – Craig Stephenson

Mrs. Hartkemeyer - We've had a few discussions about the park; how we would proceed and bring in playground equipment. We decided to bring in Mr. Stephenson to take a look at this project to see how we would want to proceed.

Mr. Stephenson – I was hired as the criteria engineer to look at the park master plan. The essence of the proposal I sent was to look at the budget for the master grading. It was determined that we could put some drainage and grading in at a much lower price. I believe this is a reasonable step to take at this time.

Mrs. Berding – I want to make sure we do this right.

Mr. McAbee – It sounds to me like most of this \$24,000 is already included in the PES

installation?

Mrs. Vonderhaar – No.

Mr. McAbee - What are we paying \$284,000 for? When the bid came into the Parks Committee it was \$240,000. Then we were left out and you met with them. I'm not sure what you added and didn't add.

Mrs. Vonderhaar – That's all the playground equipment, the big turf hill; this is a big playground. It includes installation, drainage, etc. and we did add swings.

Mrs. Berding - How does all of this work together?

Mrs. Vonderhaar - That's why we hired a consultant firm.

Mr. Barlow, PES – Further discussed the park and changes within the area. We went through 4 or 5 iterations of the park. This cost will take care of everything while we're there.

Mrs. Hartkemeyer – Mr. Barlow's company, Playground Equipment Services, has a sister company that donated \$3,000 to the Veterans Memorial Park. Thank you for that! What I'm hearing with this plan is that we can proceed.

Mrs. Berding - This was 2 meetings ago. This was my entire push to get this site ready for all future park development.

Mr. Tubreuggen, Parks Committee – I think we need to step back and relook at this. The Parks Committee needs to be involved in the Veteran's Memorial Committee. It's only right that we have some input on this since the Parks Committee and the Veterans' Committee has put a lot of work in this. There appears to be no plan. It appears that your moving forward with something completely different.

Mrs. Vonderhaar - Nothing about the Veterans Memorial has changed.

Mrs. Hartkemeyer - What's your vision for getting the playground equipment installed? Summer? Fall?

Mr. Tubreuggen, Parks Committee – I don't think we need to get into this now. Its my contention it shouldn't have been delivered.

Mrs. Hartkemeyer - Should we delay the playground installation?

Mr. Tubreuggen, Parks Committee – I don't know.

Mrs. Hartkemeyer - We need to move forward with this.

Mr. Valerius, Park Committee - Continued discussion about veteran's memorial.

Mrs. Hartkemeyer - Do we need to take action on this tonight?

Mr. Valerius, Park Committee - We need to get the central core installed.

Mr. McAbee - Can we do this right now?

Mr. Valerius, Park Committee - Yes.

Mrs. Hartkemeyer - What I'm hearing is we have money together to do a Phase I. We have the playground pieces. We just need to work together to hash out the middle section. Do we need to approve this?

Mr. Barbiere - I think if you're going to approve a plan the people should get together unless you want to vote on this plan.

Mrs. Hartkemeyer - I'm hearing this is a plan that could be changed on the fly. Do we need to take action on this tonight, or do we want to have everyone work through the pieces?

Mr. Barbiere - You could vote on this at the next meeting.

Mrs. Berding – Julie you have everyone's contact information?

Mrs. Vonderhaar - Yes. Mrs. Berding - Can you get them together? Mrs. Vonderhaar - Yes.

Mr. Barbiere - Are you asking me if its legal? I don't think there is anything illegal about that. You can't pay it or enter into a contract unless its been appropriated. I think you can open a PO before it's been appropriated. I can tell you I just researched this a few weeks ago for another township and there is very little law on that subject. Normally its not done but I don't believe its illegal.

Mr. McAbee - We can't spend the money if it's not appropriated.

Mr. Barbiere – True.

Mrs. Berding - Your point is that your calling out that we need to appropriate the money for CUC? I'm trying to get clear on what you're saying.

Ms. Schultz – Did I do something wrong?

Mr. Barbiere - No.

Ms. Schultz - I did appropriate the money. I used the resolution that you approved to spend the money as the backup. The money is appropriated. In order to put the money in the system you have to reference the resolution number. I did not do a formal resolution to amend the resolution. I used the resolution that you approved for my backup.

Mr. McAbee - There must be a resolution to appropriate the money.

Mrs. Berding – We did pass the resolutions. Are you saying there should be additional resolutions to amend the resolution?

Mr. McAbee - It has to be amended in a formal process before it can be spent.

Mrs. Berding - Just to recap what you are saying is even though we passed 2 resolutions for these projects and although we have resolutions approving the loan and the 2 projects, we need to do additional resolutions to amend the appropriation?

Mr. Barbiere - That is what is normally done.

Mr. McAbee - Remember I asked what account these are coming out of because it needs to be appropriated.

Mr. Barbiere - It's not unlawful to open a purchase order before the money has been appropriated.

Mr. McAbee - It looks like you put the money in the TIF.

Ms. Schultz - Yes.

Mr. McAbee - Did you get a legal opinion?

Ms. Schultz - No.

Mr. McAbee - I guess we need to pay the school district 25% of that. It doesn't belong in the TIF income. Does it?

Mrs. Hartkemeyer - Can we address this and make sure we are doing everything right? **Mr. Barbiere** - Yes, we can fix this.
