Board Discussion – Should we plan a discussion with residents with an open house setting. Send out surveys. What do our residents want in the Township. Let's put together 3 – 5 questions from each trustee for our next meeting and submit to administrator and then we can have on our next meeting to discuss.

• Fire Department vehicles – Chief Thomas

At our last meeting we had discussions about vehicle purchases. We also discussed a sales agreement in order to lock the pricing in and make sure we have an escape clause within that. I was able to get quotes from two ambulance manufacturers and fire apparatus manufacturers. The fire manufacturer agreed to a 12-month escape clause to exit that contract with no penalties. The one ambulance manufacture said we could exit at any time with no penalty since they could know they could sell it. Horton, which was the lowest quote said we could exit up until the build meeting and we could exit that without any penalties. The ladder truck came in at just under \$1.5 million. When we first talked about this it was in the \$900,000 range. There is a 34-month delivery date. The ambulance was \$268,000. The service department had asked for a truck to be used for signs and other work assignments. They wanted to get a utility body truck to do that. The current F-250 that the Fire Department has is in excellent shape but with the trailers we have to tow its only F-250. I asked Jeff if the Road Department would be interested in that vehicle. We could negotiate a deal that they would end up with our F-250 and we would buy a larger vehicle, an F-550. This would give us the towing capacity for the safety house. The quotes for the ladder truck, ambulance and service

department are on state bid. The opportunity to lock in this price from going up is a great advantage for us. The vendor for fire truck is Voglepohl Fire Equipment out of Kentucky.

Mr. Berding - I understand the medic unit I'm having some apprehension about the fire truck. \$1.5 million is a tough pill to swallow. I'm having a lot of apprehension about the F-550 to pull around the smoke house. That seems like a lot of money to pull around the smoke house to events. The current vehicles we have can't pull round the smoke house.

Chief Thomas – Its not only the smoke house but also the new utility trailer we have.

Mr. Berding - For something not used every day for fire rescue it's difficult for me.

Chief Thomas - When you look at the cost of truck and divide it by the minimum 10-year lifespan it brings it to a much more reasonable expectation.

Mrs. Hartkemeyer - I'd like to see what our vehicle plan is for the next 5 years.

Mrs. Vonderhaar - Chief has always had a nice vehicle plan.

Mr. Berding - I appreciate the education on the need. What direction do we want to go? I think we should go out and get a contract on a medic. Let's get a resolution on the next meeting.

Mr. McAbee – I'm ok on the ladder truck.

Mr. Berding - What is your opinion on the F-550?

Mr. McAbee – If there is something out there that is not an F–550 we should look into that.

Chief Thomas - Valley Ford has the statewide contract. This is not on the ground. She would place this order but couldn't tell me when that would happen.

Mr. McAbee - Let it stand for the first read tonight and finish it up on June 1st.

DEPARTMENT SPOTLIGHT - Jeff Bennett - Public Works

It is our mission to serve our community with the highest quality and workforce for the day-to-day operations. This department maintains approximately 33 acres of parkland not to mention the 1.3 miles of bike trails. We have the responsibility of maintaining approximately 80 lane miles of roadways with more to come. This past snow season we used approximately 451 tons of salt along with 2041 gallons of brine mix. Currently we have 8 full-time employees. We also maintain the storm water systems throughout the Township along with maintaining open ditches. Storm water basins are an ongoing issue due to the age of these. The push camera has saved us countless hours. We now have a total of 9 dump trucks. We also have trucks for everyday use. We now have a building that we are very proud to call our workplace. It is our vision to serve our community with the core functions of public works.
