OLD BUSINESS/ITEMS FOR BOARD DISCUSSION

Set Organizational Meeting Date – January 5, 2022

Mrs. Berding - What are thoughts of the Board?

Mr. McAbee -5^{th} is ok with me.

Mrs. Hartkemeyer - Do we want to have on the 5^{th} or the 12^{th} ?

Mrs. Berding – OK let's have it on the 5th at 7 PM.

• Set December meeting Date – Appropriations

Mrs. Berding – I understand the permanent appropriations would be available on November 30th by the end of the day. The meetings currently in December are scheduled for the 8th and 22nd. I would like to propose that we maintain the meeting December 8th. And, if we need a second meeting in December to have that on the 22nd. In December I'm not available on the 15th.

Mr. McAbee - I think the 8th would be fine. I would like to see them be temporary appropriations so that the trustee elect would be involved. I would recommend that you do 25% and then when the new Board is in place then we can have some input.

Mrs. Hartkemeyer – Does that cause any additional work for your office vs. temporary instead of permanent?

Ms. Schultz – Actually I'm unsure. I'll have to research that. I think the document you look at would be same. I don't know how that would go with writing PO's the first of year. This would be my first time doing it this way.

Mr. McAbee - If you appropriate 25%, we have to adopt a permanent near the end of March. Certainly, we could appropriate enough money to get through the first 2 months.

Mrs. Vonderhaar - Certainly it does create more work, it's an extra step. This would double the work.

Ms. Schultz - We would have to enter 25% in UAN and then take back out and put in again.

Mrs. Berding - I can see the point of doing temporaries to make sure Trustee Berding is involved. Even if we do permanent appropriations there is always an opportunity to amend those. Mr. McAbee what is the advantage of doing temporary

appropriations vs. permanent that you can adjust or amend anyway?

Mr. McAbee - I guess it just depends on the Board. It would allow the new Board to have more input vs. reallocate funds. That sounds like more work to me.

Mrs. Berding - I would say, Ms. Schultz, do some research and find out what works best for your office. I do believe there is always that opportunity to amend. That would be my guidance.

Mrs. Hartkemeyer – Especially if we can amend it later. I have no problem with our Trustee Elect commenting at the December 8th meeting. I would assume that if our Trustee Elect is interested in obtaining the budget on November 30th, I would just request that it went ahead and be sent to him, so he has time to review it as well. I think we need to be sensitive to Fiscal Officer Schultz's workload.

Mrs. Berding - At any rate, we will maintain our meeting on December 8th and we will plan to talk the appropriations at that time.

Mr. McAbee - So that absolutely takes the Board out of the discussion, and we will be presented with numbers on the 30^{th} and expect to adopt them on the 8^{th} .

Mrs. Berding - So say we don't adopt them we would maintain our 2nd meeting. Correct?

Mr. McAbee – Mr. Berding doesn't get a vote in December. He should be entitled to weigh in on appropriations for next year and vote on them.

Mrs. Berding – Ms. Schultz think about it, and I would defer to your expertise. I don't think it takes the trustees out of it. I don't think it takes Mr. Berding out contributing his ideas to that once he has voting rights after the first of the year. If there is a need to make an amendment to an appropriation, I have no doubt that can be done.

Ms. Schultz - Just to make a couple points; you approve appropriations by fund in total so we already can move money in between accounts if it's in the same fund. Also, if it's budgeted for over \$5000 it can't be spent unless there is a resolution. So, Mr. Berding could say no at that time.

Mrs. Hartkemeyer - Everything has to come before the Board anyway if it's over \$5,000. So, the Board will have an opportunity to vote yes or no.

• 1% Salary Increase –

Mrs. Vonderhaar – the Police contact was passed, and they were given a 3% raise and the nonunion was awarded 2%.

Mrs. Berding - So since the FOP negotiations went on longer than expected and most of our staff were due for raises in April we decided to go ahead and award a 2% salary increase to the rest of our staff while we were still negotiating the FOP contract. Now that the FOP has come back with a 3% increase, we need to decide are we going to do what we have done in the past and give our staff that additional 1% increase.

Mrs. Hartkemeyer - We generally provide parity with the staff.

Ms. Schultz - Estimate of impact was sent. It would be approximately \$8,800. That would include the firemen, but we have decided not to do anything with that since they are negotiating a contract. So, it would be less than the \$8,800. Fire is about \$1,700. Just to be clear it would be back to 10/7.

Mrs. Berding - Can we have a resolution at our next meeting? One for Mrs. Vonderhaar and one for the rest of our staff.

Mrs. Vonderhaar – The next 2 are just final PUD's that need to come before the Board. The drawings and plans are in your mailbox. I was looking to see if that would work December 8th.

Mrs. Hartkemeyer – I'm fine with that.

Mrs. Berding – Fine with me.

Mr. McAbee – I'll be here and I'll be ready.

• SAFER Grant for the Fire Department

Mrs. Vonderhaar – The SAFER Grant has not opened for the cycle. It should open anytime in November all the way through February. The Fire Chief is hoping to submit and that would cover firefighters' salaries all the way up to 3 years.

Mrs. Berding - How many firefighters?

Mrs. Vonderhaar – He's asking for 9.

Mrs. Berding - I don't think there is any harm in applying for it. If we are awarded the grant do we have to accept it? How is that viewed?

Mrs. Vonderhaar – We don't have to accept. I don't know how that is viewed. I don't know that we would want to turn it down. Nine doesn't necessarily have to be the number if the Board isn't agreeable to that.

Mrs. Berding – I think it would be great to have more full-time firefighters. I think there is all kinds of advantages to that. It concerns me a little to pay for these 9 firefighters for 3 years. What happens at the end of the 3 years? Would we be prepared to support those full-time salaries? I'd like to see some more financial analysis. If we hire 9 more does that take away x-number of part-time people that we would need to maintain. Would it take away overtime we are paying now? I'd like to understand more before we commit to it.

Mrs. Hartkemeyer – I agree, and I'd like to make sure at the end of the 3-year period that we have the ability to sustain those positions without depleting our Township resources. I'm hoping that our economic development that we've worked hard to achieve will help to fund those positions going forward. I think we need to make sure that is the case because I'm not particularly interested in asking the good citizens in Fairfield Township for a levy.

Mrs. Vonderhaar - The ultimate goal is to get to 12 full-time. That's a large ask and we are deficit spending in the fire account. I don't think we can depend on money we don't have.

Mr. McAbee – You're talking about hiring 9 more? This is the first I've heard of it. Have you been meeting without me?

Mrs. Vonderhaar - This is why I'm bring it up tonight.

Mr. McAbee - I think we should bring the Chief in to discuss the short staff and overtime.

Mrs. Berding - Why don't we take some time to have some numbers; what would 9 full time firefighters cost us vs. what could it save us in overtime. Is it going to alleviate staffing issues? How many fewer part timers could we carry on the roster? Maybe we can have this information on the 12th and have the Chief come in. Just to clarify, when I do this, is it fair to meet the department heads without the trustees? Mr. McAbee - I think this is great and if we could get some kind of report. I look forward to reading anything and everything that we can get.

Mrs. Hartkemeyer - I'd like to remind everyone about the work and the discussions we've had about our process for meeting preparation. We have enough time to bring ourselves up to speed on meetings. It is not the fault of the administrator to not bring ourselves up to speed on that. It is not the fault of the administrator for us not be inquisitive.

Mrs. Berding - I think the intention of this was to not ask for a decision tonight. This is a decision that's coming. Let's put out all our questions now.

Mrs. Vonderhaar - ADMINISTRATOR'S REPORT

Right now, we do have several grants in the works. The large Storm Water Program: the county is evaluating if they are going to continue that. We have applied for 2 separate MORE Grants; 1 for fire and 1 for police. Both are for emergency scene equipment. Each department can be awarded up to \$1,000.

We're also applying for the 2022 EPA Recycling Litter & Prevention Grant which we typically apply toward the Spring Cleanup Day. The Fairfax CDBG program began October 26 and is slated to be complete before Thanksgiving. Originally with the CDBG grants that we applied for 1 was for a playground in the 5-Points area and a basketball court we also applied for air quality control in all buildings related to COVID. We should hear on this mid-November. The Opioid Settlement did come through. We're still researching this settlement. Toys For Tots collection is going on at the Fire Department through December 9th. We have submitted paving for black mat and curb and gutter. Once we have prices back, we'll be submitting to you for discussion and resolution.

Mr. McAbee - I wanted to know where we are on this year's paving. Is it finished? **Mrs. Vonderhaar** – Paving should be wrapping up. I think it will be finished this week.

Mr. McAbee - When the new Board is seated, I'd like to talk about doing something different with the curbs and gutters.

Mrs. Vonderhaar - The company we've used is out of business. He is retiring. Mr. McAbee - Did we get the table replaced at the 5-Points Pocket Park? Mrs. Vonderhaar — Yes, it has been replaced. We've also ordered a spare. We're working on fencing there because the fencing has some damage.

Mr. Ken Geis – Mr. George Glover of Focused Capitol Solutions, an affiliate of Taft Stettinius & Hollister offers governmental relations and public policy service es to assist clients with a wide range of policy issues at the local, regional, state and federal levels of government. I'm a huge supporter of him and all that he has accomplished. I think he would be incredibly helpful to the Board and the Township. Specifically, to your project that is related to the Veterans Memorials Project and an application for a capitol grant. A Capital Grant Program is a biannual budget that goes with the Ohio legislature. In my experience having an advocate in the state house is incredibly helpful to present your case.

Mr. McAbee - Would the \$24,000 come out of this \$50,000 commitment? **Mrs. Berding** – I don't think so because this won't be dedicated to the Veterans Memorial. I think there are a number of things we would pay. Its consulting fees not brick and mortar. I think the amount a township can commit is limited by the ORC. Does our max contribution come out of the \$50,000 I think that is Mr. McAbee's question.

Law Director, Ms. Kathleen Barbiere - I would think you could bring it from any fund; not just a specific project.

Mrs. Hartkemeyer - I would think this is not going to be a stand-alone contract.

He would be assisting with other projects as needed.

Mr. Ken Geis – In my opinion I think it would be a mistake for Mr. Glover to just work on the Memorial project. I think it would be a more global approach to enter into an advocacy contract for programs that could include the Veterans Memorial.

Mr. McAbee - The resolution only states one item and that is the Veterans Memorial.

Law Director, Ms. Kathleen Barbiere - It may make some sense to re-tool your resolution to make it more of a general contact with Mr. Glover to have more freedom with what you apply him to.

Mrs. Berding - The resolution does say to provide advocacy services and to assist in obtaining a grant for the Veterans Memorial Project.

Law Director, Ms. Kathleen Barbiere - If you want to be more comfortable you can just take that veterans memorial language off.

Mr. McAbee - I'm not voting for it either way. I don't think we need a lobbyist. **Mrs. Berding -** Can we amend the resolution to remove the specific reference to the memorial project?

Law Director, Ms. Kathleen Barbiere – Yes, we can amend the resolution.

Ms. Schultz - So I don't have to rewrite it can we just make a motion to amend it? **Motion,** made by Mrs. Berding to amend Resolution #21-155 to remove "veterans memorial", second by Mrs. Hartkemeyer to adopt Resolution #21-155.

Mrs. Hartkemeyer - I think the veterans committee still has a lot to work on. I know the veterans committee works very hard to raise money. So perhaps this would be a little bit of help to get this project done.
