• Update on 2023 Paving, Black Mat and Retrace (Administrator)

Mrs. Vonderhaar – Update from Butler County 2022-2023 paving schedule. Curb and gutter were quoted and bid out. 2023 paving is very aggressive. Recommendation has been sent to Board.

Mrs. Hartkemeyer - I don't think we need to take action on this now

Mrs. Vonderhaar - Update on drainage on their Millikin Road property. Dredging the pond is very costly. In order to get the pond dredged we would have to get a lawsuit. We are trying to get a grant in order to re-route water. This is ultimately not our responsibility, but we can be partners. I've been told this could be up to \$50,000 to drain the pond. This is an intense and long process.

Mr. McAbee - Can we share in responsibility?

Mr. Goins, Zoning Administrator – There has been additional issues brought up with easement issues. Time and water have eroded this substantially. There has been some cases of junk and debris issues.

Mrs. Vonderhaar - Chuck has done an excellent job on this! Reaching out to anyone and everyone.

Mr. McAbee - There are 44 houses in this HOA. The draining of the pond needs to be done. I put the HOA on notice that they are responsible for.

Mr. Berding - Who owns the property?

Mrs. Vonderhaar - The pond is owned by the HOA.

Mr. Goins, Zoning Administrator - The HOA records it as an easement and they are ultimately responsible.

Mrs. Hartkemeyer - Can HOA's be absolved of their responsibilities? Does the Township suddenly have to take responsibility?

ADMINISTRATOR'S REPORT

Mrs. Vonderhaar -

- <u>Electric aggregation</u> Current aggregation expires November 2022. They are currently trying to find a price that beats Duke Energy. They are not recommending that we renew but revert back to Duke pricing. The earliest lower price contract would be Spring of 2023.
- <u>Ohio Issue One</u> This will be placed before the Board this evening for consideration to support. A "yes" vote supports amending the Ohio Constitution to require courts to consider factors such as public safety, the seriousness of the offense, a person's criminal record, and a person's likelihood of returning to court when setting the amount of bail. This relates back to the incidence we had at Walmart.
- Youth coalition update Junior and seniors will come in this week.
- <u>Splashpads/Park</u> We are getting some quotes and information on this.
- <u>Greenlawn</u> Completion will be November 2022.
- <u>Medians</u> Fall banners are up.
- <u>Bilstein Boulevard Bridge Rehabilitation</u> The construction of this project is scheduled to begin in Spring 2024 and be complete by December 2024.
- <u>Humana</u> We had the most successful biometric screening this year. I have scheduled blood drives for January. CPR classes were attended by our administrative staff.
- <u>Grant submittals for Milton Park</u> Chuck Goins, we did receive funding and all the contracts are worked out with the county. Proposals have been sent to the Board for

current options for the playground. We have \$160,000 in the grant. Due to increased costs, it would now be close to \$200,000.

• Applications have been submitted for 5 grants. Chuck did an excellent job.
