We need to make these subdivisions separate.

Rick Fine 3713 Conley Bottom Ct - I'm here representing the residents of Rentschler Estates and the HOA Board, which I'm Treasurer of. As you may remember in 2017 the Board disapproved MI Homes at that time. Many residents of Rentschler Estates Subdivision and surrounding communities commented during the public comment period and expressed strong objections to this subdivision going in for a number of reasons.

Mike Oler 5545 Foxglove Drive – I come as a resident and President of HOA. Our concern with MI Homes is what you have planned there. I am encouraged now that MI is willing now to meet with us and the HOA, member of the Board and the whole community and present a plan to us.

Bernie Campsen 6270 Walden Creek Ct - I'm here speaking as a homeowner. It's very concerning as a homeowner in Fairfield Township that the value of homes that might be going in near Rentschler Estates.

Dave Slavoski 4356 Foxglove – Due to the process in zoning MI Homes stated here is our plans and we really can't change it. What has been lacking is communications. Let's send a list to HOA residents and ask for their top 3 priorities.

Dick Harvey 5536 Foxglove - I'm a member of the board of HOA. I just want to reiterate that these concerns should be addressed in great detail before any decision is made.

Dave Wilson, 3808 Hibiscus – I've worked in water & sewer and I'm familiar with these proceedings. I do know that if an elected official approaches another elected official and make a recommendation that will have a lot more weight than what we can do. I would like the Township to draft a letter to Mr. Wilkins as well.

Everything for zoning can be done virtually with this this new software.
