As far as the procedure standpoint we have an error in that and have made some adjustments to remedy those in the future. We've discussed these adjustments with our administrative staff and our law director.

Mr. Barbiere, Law Director - The hearing could go forward but it would not be in compliance with Section 409 of the zoning resolution. Although the non-compliance would not mean that any amendment would be invalid. The other choice would be to open the public hearing which has been done and continue the public hearing in progress until July 28th which is the next meeting and then reopen the meeting and let everyone testify then. Then after that the Trustees could vote. The Trustees have 20 days to vote from today when they reopen the public hearing to make a decision.

Mrs. Berding - I do agree with option 2 since the applicant is not here. I would like to give everyone an opportunity to be here.

Mrs. Hartkemeyer - I like option 2 as well.

Mr. McAbee - Why isn't the applicant here? Was he told there was a malfunction? **Mr. Goins** – We did reach out to the applicant to let them know there was a potential to continue the meeting. Both applicants are available for July 28^{th} .
