They understood the feelings of the Trustees, and we were able to get them to agree, and they have signed the Last Chance Agreement.

LAST CHANCE AGREEMENT

Nesh Mahat, Fraternal Order of Police, Ohio Labor Council, Inc. (hereinafter referred to as "the Union"), and Fairfield Township, for mutual consideration, the adequacy of which they each acknowledge, hereby enter into this Last Chance Agreement and agree as follows:

- 1. As an alternative to Fairfield Township seeking Nesh Mahat's discharge for charges of violating FTPD Policy 321.4 General Standards; FTPD Policy 321.5.1 (b) Laws, Rules, and Orders; FTPD Policy 321.5.8(i) Performance; and FTPD Policy 321.5.9 (m) Conduct, related to events which occurred on August 10, 2025, wherein Nesh Mahat was placed under arrest for Operating a Vehicle While Impaired and Obedience to a Traffic Control Device, Nesh Mahat, the Union and Fairfield Township have agreed to enter into this Last Chance Agreement as a full, final and complete settlement of this matter.
- 2. Nesh Mahat will be placed on a 30 day suspension without pay for violating the policies described in paragraph 1 above. By signing this Agreement, Nesh Mahat admits guilt with respect to the above charges and waives his right to a hearing.
- 3. Nesh Mahat and the Union will waive their respective rights to grieve or otherwise challenge the disciplinary action described in paragraph 2 above, under the Collective Bargaining Agreement between Fairfield Township and the Union, through Civil Service or through any other applicable procedure or legal means.
- 4. This Last Chance Agreement is not precedent setting and may not be cited as precedence or referenced in future disciplinary matters involving any other members of the bargaining unit other than Nesh Mahat.
- 5. The discipline specified in paragraph 2 above and the other terms of this Agreement provide Nesh Mahat with a "last chance" to correct his behavior. Nesh Mahat and the Union agree that the terms as set forth in this Last Chance Agreement are reasonable conditions for Nesh Mahat to comply with in order for him to save his job and continue his employment as police officer with Fairfield Township. Nesh Mahat and the Union acknowledge and agree that if Nesh Mahat engages in any further

misconduct or violation of *any* type including, but not limited to, any unauthorized absence, letter of counseling, written reprimand, or any offense as set forth in the Fairfield Township Police Department Policies, for the next *four* years from the below date of execution that it will constitute "just cause" for his discharge from employment with Fairfield Township for which Nesh Mahat and the Union will *not* grieve or challenge under the Collective Bargaining Agreement between the Township and the Union, or through any other applicable procedure or legal means. After 4 years, this discipline will cease to have any force and effect as it relates to progressive discipline.

6. Nesh Mahat acknowledges and agrees that he has received full, fair and adequate representation from his Union throughout this matter and that Nesh Mahat and the Union enter into this Last Chance Agreement knowingly and voluntarily. The rule of construction or interpreting a contract against its drafter will not apply to this Last Chance Agreement.
