Items for Old Business:

A. Special Events. At the last meeting I asked the board to give us directions on whether we should continue having special events for the year due to our declining budget numbers. You all asked us to compile the amount of money that was spent last year on 2024 events. We spent \$71,314.90 (\$18,209.85 for Spring Clean-up Day and \$53,105.05 for all the others). We collected \$21,100.00 in donations for Patriots Day and \$1,100.00 for Spring Clean-up Day for a total of \$22,200.00. In additional to these costs, we also spent \$47,871.26 in overtime for providing the manpower for all these events. (Total spent in 2024 \$119,186.16).

- We have a rate guarantee from last year and there will be no increase in cost to the township.
- 7. 25-106 Resolution Authorizing the Administrator to Execute a Salt Contract with the Buter County Engineer's Office for the 2025 & 2026 Snow and Ice Control Season. The county bid the salt contract for this year, and we will now pay \$96.40 per ton vs \$92.12 (4.6% increase). The new contract is with Compass Minerals.
- 8. 25-107 Resolution Declaring the Necessity of Levying an Additional Tax in Excess of the Ten-Mill Limitation within the Township and Requesting the County Auditor to Certify Matters in Connection Therewith (2.9, 3.9 or 4.9 mills). We asked the Auditor to certify three different millage amounts for a fire levy. We have an incorrect ORC reference and will need to fix and resend one resolution for the auditor to respond to. We do have the amounts for each millage. They are:
 - a. 2.9 mills \$2,307,516.00. The cost will be \$102.00 per \$100,000.00.
 - b. 3.9 mills \$3,103,211.00. The cost will be \$137.00 per \$100,000.00.
 - c. 4.9 mills \$3,898,906.00. The cost will be \$172.00 per \$100,000.00.

Mr. McAbee brought up at the last meeting his thoughts on bringing forward 3 levies for the residents to vote on. If you decide to do that, the numbers indicate that we would need a 2.9 mill levy for the police department (which would get us from 2026 through 2029), and a 3.9 mill fire levy (which would get us from 2026 through 2030), only if you split the safety services levy in half. We really would not need a road levy because then we could use JEDD/RID money to fund the road operations and pay for capital expenses. If the choice is to do one fire levy, then we would need a 4.9 mill levy to get us from 2026 through 2030 and use the safety services levy/JEDD to fund the police department and the JEDD/RID to fund the public works department.

The auditor has asked that we pick one amount and approve a new resolution for them to certify. A second meeting on July 8th would then become necessary so that a resolution to proceed could be approved.

Other Items:

- 1. Nothing to report on the fire station project.
- 2. We have been working on updating the information for benefits in the ADP system due to the changes in dental, vision and voluntary life through Principal, and our basic life through Standard. Please make sure you visit your profile before June 30th to select your choices. The open enrollment meeting will be held on Friday at 9:00 a.m. here at the administration building.

FAIRFIELD TOWNSHIP RESOLUTION NO. 25-101

RESOLUTION DECLARING NUISANCE AND ORDERING ABATEMENT ON THE PROPERTIES LISTED BELOW AND FURTHER AUTHORIZING THE ZONING ADMINISTRATOR TO INITIATE COMPLAINT.

WHEREAS: Uncontrolled vegetation, unsecured property, improper parking of vehicles, and/or refuse, junk, and debris were reported at the properties listed below; and

• 6158 Osage Dr- Vegetation

Vegetation, Junk, Trailer Parking

WHEREAS: The Ohio Revised Code Section 505.87 provides that, at least seven days prior to providing for the abatement, control or removal of any vegetation, garbage, refuse or debris, or securing the property, the Board of Trustees shall notify the owner of the land and any holders of liens of record upon the land; and

WHEREAS: The Fairfield Township zoning resolution outlines zoning guidelines to promote public health, safety, comfort, and welfare of the residents of Fairfield Township. Violations of a provision of the resolution have been observed and proper notice has been delivered; and

WHEREAS: The Ohio Revised Code Section 505.87 provides that, if the Board of Trustees determines within twelve consecutive months after a prior nuisance determination that the same owner's maintenance of vegetation, garbage refuse, or other debris on the same land in the township constitutes a nuisance, at least four days prior to providing for the abatement, control or removal of the nuisance, the Board must send notice of the subsequent nuisance determination to the landowner and to any lienholders of record by first class mail; and

WHEREAS: In accordance with Ohio Revised Code Section 505.87, the Township Trustees have the authority to contract to abate the nuisances and have the costs incurred assessed to the property tax bills;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: That this Board specifically finds and hereby determines that the unsecured property, inoperable vehicles, improperly stored vehicles, uncontrolled growth of vegetation and/or the refuse and debris on each of the said properties listed above constitute a nuisance within the meaning of Ohio Revised Code Section 505.87, and the Board directs that notice of this action be given to owners of the said property and lienholders in the manner required by Ohio Revised Code Section 505.87.
- SECTION 2: That this Board hereby orders the owners of said property to remove and abate the nuisances within seven days after notice of this order is given to the owners and lienholders of record, and within four days after notice of this order is given to the owners and lienholders of record for properties previously determined to be a nuisance. If said nuisances are not removed and abated by the said owners, or if no agreement for removal and abatement is reached between the Township and the owners and lienholders of record within four or seven days after notice is given, the Zoning Administrator shall cause the nuisances to be removed, and the Township shall notify the County "Auditor to assess such cost-plus administrative expense to the property tax bills for the said parcel, as provided in Ohio Revised Code Section 505.87.


