PRESENTATIONS

Park Update by resident Carol Oler

Two new members were brought on board to the parks committee. Dawn Alcorn, which was present at the meeting and Ralph Terbrueggen, who was not able to attend this board meeting. The parks committee had a meeting on January 9, 2018 to discuss current items being worked on as well as a wish list of items they would like to do in the future. Currently the dog park is their biggest project and it's almost complete; the fence is up, there is a cement walk way, a cement pad, water for the dogs and dog disposal. The signs will be up soon. The parks committee would like to have an official Grand opening when the weather is better.

The parks committee would like to pursue a crosswalk to cross Vonnie Vale to get to the dog park. The 3 steps to get a crosswalk include: 1) Install signs that we get through the engineers' office. 2) Stripe the crosswalk with paint. 3) Get a push button feature for the crosswalk.

The parks committee needs to get mulch for the playground. They are considering moving to a rubber mulch.

They are looking at adding a new piece of playground equipment.

Mrs. Oler stated that parking could become an issue if we have any major events at the parks. The committee is looking for ways to add more parking and post signs where to park. Mrs. Oler is working on a possible splash pad addition.

The committee is also working on getting landscaping done around the dog park.

Fire Department

I am working on a new "drug bag" exchange in which the hospital will exchange drug bags with the Fire Department when the medications are close to expiring. This will help to eliminate the cost of expired medications. The hospital can use the medications before the expiration date and the Fire Department gets new medications to fill the bags.

Police Department

Chief Chabali – Stated calls were up in every category for the year. The Police Department did the "Shop with a Cop" program for Christmas. I have processed 3 applicants to be considered to be hired. One applicant dropped out for another position and the other 2 failed the polygraph test. I will be bringing in 2 more applicants to be tested. I am working on my annual report. Chief discussed the Narcan program success. I am working closely with the Opiate task force on this program. Ramona Sharp works in Butler County and is partnering with the police to follow up with Narcan recipients to help them further.

Service Department

Jeff Bennett – Handed out a revised paving schedule. The original paving quote was \$690,000.00, since then two jobs were eliminated bringing the new total to \$476,000.00.

Trustee Hartkemeyer – Asked if this was in conjunction with the Townships long term paving plan and Mr. Bennett stated it was.

Mr. Bennett asked the Administrator to post on social media when weather conditions arise that it would be helpful to move cars from cul-de-sacs and park on outgoing lane.

Zoning Department

Chuck Goins - The month of December 5 permits were issued. We had 2 complaints of zoning violations and 17 past complaints resolved. Tentative date for FTZA17 is February 15, 2018, location not yet determined. The new proposal includes 20 less units, reducing the buildings from 9 to 8. Jo-Ann Fabrics is looking to do a commercial remodel at the old Office Depot building for their store.
