PRESENTATIONS

Proclamation in Honor of Kyler Bradley

Trustee Hartkemeyer – Presented proclamation of Kyler Bradley DIPG National Awareness Day. Kyler was made an Honorary Fairfield Township Fire and Police Chief. Fairfield Township would like to recognize Kyler for his brave battle against this disease and show our support. May 17th will be the official yearly date of recognition as Kyler Bradley National DIPG Awareness Day.

2nd Quarter Outreach Schedule

Julie Joyce-Smith - Butler County Auditor's Office - The tax filing deadline was March 31, 2018. At our prior triannual update, we had 1,400 case disputes. This year we have 760, of which 29 cases are Fairfield Township. Of the 29 cases, 8 cases will impact the TIF. We have moved our appraisals in house and feel we are moving in the right direction. Ms. Schultz has all the information to crunch the numbers. Tax decreases will be immediate and will reflect on the second half settlement. Tax increase will start in December for first half settlement next year. 2020 tax year will be our next appraisal update. Our staff is currently working on this, they are doing this in phases. Potentially the first part of June they will be doing Fairfield Township, vans are clearly marked as part of the photo project.

We have received complains about gas, which we are working on. The statewide testing program is not in existence in Ohio. Ohio does not currently have a fuel quality testing program. In reference to skimmers we have not found any additional ones, we are continuing to look for them, especially around the holidays.

ITEMS FOR BOARD DISCUSSION

Creation of a Community Enhancement Committee

Mrs. Vonderhaar - Many Township residents have expressed an interest in getting involved in the community. These are residents that could benefit the Township in so many ways. Would like to get the Boards approval to create a Community Enhancement Committee where these residents can use their passion and desire to get involved in the Community.

Trustee Hartkemeyer – I like the idea, want to get a legal opinion.

Mr. Barbiere – I have no legal concerns.

Trustee Berding – I love the idea. There are events we could do with the talent of our residents. Who will lead this committee?

Mrs. Vonderhaar – I would be happy to lead with the help of Mr. Goins or possibly a resident would like to lead.

Trustee McAbee – Sounds good, would like to see what this does.

ADMINISTRATOR'S REPORT

Mrs. Vonderhaar - I provided a firehouse update. CUC is currently working on foundation plans so they can be submitted to the County. Roof and block have been ordered. Chief Thomas has been doing a great job working on the alerting system, signage, data cabling, computers, phones, furniture, bedding and Plymovent, SBCA compressor/fill station. CUC is working on civil drawings to outline the lot, work on the easement for draining and a possible Veterans Memorial Park area behind the station. Spring clean-up day was our best one ever. Chuck Goins did an amazing job. He will give us more information during his departmental report.

Trustee McAbee – Concerned about the Veterans Memorial Park location being behind the firehouse building. Residents want to be able to easily find it.

DEPARTMENTAL REPORTS

Fire Department

Chief Thomas – Stated his monthly report was submitted by Assistant Chief Schumann. Continuing to work on the firehouse. We have 8 additional applicants and we have our hiring process in place. By the end of summer, we should be prepared to have everyone hired. The newly hired firefighter went to shift 1 at headquarters.

Police Department

Chief Chabali - During Township clean-up day we received 45 pounds of prescription drugs at our drug take back program. This is significant for our size Township. Captain Lanier will be attending Grant training on May 17th. Tomorrow we will be interviewing 11 applicants for the 2 positions we currently have open.

Trustee McAbee – According to your report calls and citations have gone down compared to last year.

Chief Chabali – Yes, we are holding steady with calls and not increasing, which is good.

Service Department

Jeff Bennett had an urgent issue and cannot be here so **Mrs. Vonderhaar** gave brief update. The Dog Park is ready for the grand opening on May 19th. The curb and gutter bid packet is currently under review. Mrs. Vonderhaar will follow up with Mr. Bennett about ADA compliant curbs.

Zoning Department

Chuck Goins – Zoning permits have been steady, 74 total for the year. Violations and complaints are increasing with grass cutting season being upon us. Spring clean-up day was a huge success with a great amount of volunteers, helpful staff and an excellent Service Department. We had 12 dumpsters jam packed full of garbage and debris. We received 800 quarts of used motor oil which we took to our local Auto Zone. We had 120 used tires which Bridgestone Tires will be collecting. We received 1220 gallons of paint containers which we donated to Matthew 25 Ministries to be reused.

Trustee McAbee - Are the Zoning permits mostly fences, pools, sheds?

Chuck Goins – Yes, mostly residential permits, some remodels for commercial properties were received in April.

Trustee McAbee – Target is remodeling some of their stores. Are they remodeling our Fairfield Township store?

Chuck Goins – Not at this time, just proposing work in their parking lot.

Mrs. Vonderhaar you are doing a great job dealing with the residents. I believe most residents are very pleased with all the positive things going on in our Township.
