TRAINING:

- Sgt. Miller and Officer Stebbins attended Week 2 of the Supervisor Training and Education Program (STEP).
- Sergeant McCroskey attended Week 2 of the Police Executive Leadership College (PELC).
- Officer Willis attended the 40-hour Standardized Field Sobriety Testing Instructor training at OPOTA.
- Command staff and all supervisors took part in the annual Police Executive Leadership College Alumni training via an online seminar. The presenter, Gordon Graham, presented a four-hour block on Organizational Risk Management.

TOPICS OF INTEREST:

- Body cam equipment was installed in the cruisers and body cams were issued to officers and deployed in the field for a testing and evaluation period. We continue to resolve technical issues for this period.
- Adult male pled guilty to Unlawful Sexual Conduct with a Minor (F4) and Attempted Trespass in a Habitation (F5) for an incident last summer where he had sexual conduct with a juvenile in her home.
- Detectives received three separate complaints regarding allegations of sexual assault involving juveniles. All three cases remain under investigation.
- Detectives followed up on leads reference a Boy Scout Troop trailer stolen from behind a church on SR4. The trailer was recovered at Advantage Self Storage on Tylersville Road along with two other stolen trailers – one stolen from Miami Township (Montgomery Co.) and the other out of Forest Park (Hamilton Co.) The suspect was identified, confessed to the thefts, and was charged with multiple offenses.
- Evening shift officers responded to the 2000-block of Exeter Street for an active domestic fight. The male subject threw his wife off the front porch balcony causing her physical injury. The male suspect fled on foot prior to officers arriving but was located and taken into custody. He was booked in the BC Jail for domestic violence and the female was transported for medical treatment.

- Evening shift officers responded to the 6400-block of Glenmont to locate a person wanted by Middletown PD for assault charges. Officers located the suspect's vehicle, but the subject refused to come out of the house after being ordered to do so. The combination of multiple officers and a K9 unit being on-scene ultimately convinced the subject to come out of the house and he was taken into custody without issue.
- Evening shift officers responded to Urban Air on Princeton Road for a large number of people fighting. The fight was broken up and officers checked on those customers who complained of minor injuries. Investigation and possible charges pending.
- Evening shift officers responded to Milton Street at Lenox Avenue for a breaking and entering in progress. Officers located three teenagers in the backyard and two of them ran from officers. Officers were able to apprehend the juveniles and one of them was charged with obstructing official business and is to appear in BC Juvenile Court.
- Evening shift officers responded to the area of Princeton Road at Hampshire Drive for a topless female driver who struck multiple vehicles. Officers located the female and discovered she was highly intoxicated. She was arrested for OVI and additional charges.
- Evening shift officers responded to the 6400-block of Liberty Fairfield Road for a fight. There they located three subjects and all three sustained injuries from the fight. They were uncooperative and declined charges; however, officers contacted the prosecutor's office and are reviewing possible charges.
- Midnight shift officers responded to the 2100-block of Lenox Avenue for a domestic violence complaint. A female stated her husband assaulted her and officers were able to locate and arrest him and booked him in the BC Jail for domestic violence.
- Midnight shift officers responded to Speedway on Creekside Drive for a male passed out or sleeping in a vehicle in the parking lot. Officers discovered the subject was intoxicated and had four prior OVI convictions in the past ten years. Officers arrested him for felony OVI and booked him in the BC Jail.
- Midnight shift officers responded to a domestic violence complaint in the 7500-block of Wildbranch Road. Officers could not get the male subject to cooperate and he refused to exit the apartment after the officers gave him verbal commands. He was inside with the victim and a couple of children, and after approximately one hour, officers were able to get the male subject to come outside peacefully where they took him into custody and booked him in the BC Jail for domestic violence, unlawful restraint, and inducing panic.
- Midnight shift officers were able to safely relocate and place a woman from Speedway who had nowhere to go during the freezing temperatures.
- Midnight shift officers responded to Morris Road at Saratoga for an injury crash where a vehicle struck a utility pole and split it in half. The driver was arrested for OVI and eight homes were without power/cable for several hours. Several of those residents were unable to get out of their driveway due to low hanging wires.
