TRAINING:

- Detectives Edens and Spradling attended the 32-hour Reid Technique of Interview and Interrogation in Cincinnati, Ohio.
- Sergeant Miller attended an 8-hour moving and shooting training class.
- Officers Robinson, Singleton, and Willis attended Great Oaks for a three-day Officer in Charge course.
- Officer Singleton attended a 24-hour tactical patrol officer course.
- In-service firearms training and qualifications started in April and will continue through May.

TOPICS OF INTEREST:

- Detectives presented a homicide case to a Butler County Grand Jury and obtained an indictment on MarkeyInd Townsend for the July 23, 2018 homicide of 16-year-old Sydney Garcia-Tovar. Townsend is indicted on charges of Murder and Felonious Assault, both with associated gun specifications. Despite these charges, this case remains open and continues to be investigated.
- The Butler County Grand Jury indicted the three males who officers/detectives arrested for the March drive-by shooting which occurred in the 7700 block of Wildbranch Road.
- Detective Edens identified a 21-year-old male out of Cincinnati as the suspected voyeur in the women's restroom at Target. The subject is charged with Voyeurism (M1) and is pending in Butler County Area II Court. The suspect is also identified as a suspect in several other similar cases in the Cincinnati area.
- Officer and detectives responded to the 5800-block of Reigart Road for an investigation of a 31 year-old female discovered dead in the house. Evidence technicians processed the scene and detectives served several search warrants, collected additional evidence, and interviewed several people. The case remains under investigation at this time.
- Officers responded to the 3500-block of Crooked Tree Circle for a male subject with a gunshot wound to the chest. Hamilton Police also received a shots-fired call in the area several minutes prior to this call. Officers

learned the shooting occurred on Pebblebrook Lane in the City of Hamilton. Officers assisted HPD during the call until they took it over.

- Detectives received a couple reports pertaining to child pornography offenses at multiple addresses in the township. Both of these cases remain under investigation at this time.
- Officers responded to the 3500-block of Hamilton Middletown Road for a two vehicle fatal crash. One driver died at the scene and the second driver died later at the hospital. The at-fault driver crossed over the grassy median and struck the other vehicle head-on.
- Officers responded to the Social Security Office on Winford Avenue for a vehicle into the building. The driver was cited for No License, Failure to Control, and the vehicle was towed from the scene.
- Officers responded to the 6300-block of Liberty Fairfield Road for a hit skip crash where the driver of the vehicle fled the scene. The at-fault vehicle was confirmed as being stolen from the area and crashed into two parked cars in the driveway.
- Officers responded to Princeton Road in front of Menards for a pedestrian/cyclist who was struck by a large pickup truck. The pedestrian suffered minor injuries.
- Officers assisted West Chester Police Department with a vehicle pursuit ending in the 2000-block of Harvard Street. The male suspect was apprehended at the scene and charged with several felony offenses for thefts of catalytic converters.
- Officers responded to Indian Trace for a domestic violence call. The reportee advised a male subject choked her and then poured a milkshake on her head. Officers arrested the subject for domestic violence and booked him in the BC Jail.
- Officers responded to the Target parking lot for an injury pedestrian strike. A vehicle backed from a parking space and pinned the pedestrian between the door and the car. The pedestrian sustained minor injuries.
- Officers responded to the 6700-block of Lester Avenue for a domestic violence call. Officers arrested the suspect for domestic violence and booked him into the BC Jail. Once there, the subject began to overdose and jail medics administered Narcan. The subject was treated at an area hospital for a couple days and once released he was booked into the jail for the felony domestic violence charges.
- Officers responded to the 3500-block of Crooked Tree Circle for a 2-year-old found walking on the sidewalk. The child unlocked the front door and got outside. The child was returned home safely, and the family contacted.
- Evening shift officers responded to Jen's Bar for a fight. An employee informed officers that a female entered the bar, had a shot, and assaulted two patrons and the employee. The subject left the scene, and this case remains under investigation.
- Officers responded to Chipotle for an Aggravated Menacing report. The caller reported that a female walked by his vehicle and her purse inadvertently scratched the side of his car. The caller approached the female and accused her of causing the scratch; however, the female pulled out a pistol, pointed it at the male, and allegedly threatened to shoot him. The female suspect was located and charged.
- Officers responded to the 2000 block of Parrish Avenue for an intoxicated male walking in the roadway. Officers made contact with the subject who then fled on foot when officers attempted to detain him for a probation violation warrant. Officers pursued him on foot and were able to arrest him on Shuler Avenue.
