## TRAINING:

- All personnel completed spring qualifications and training at the range.
- Officers completed the in-service training (refresher) course on OVI Detection and Standardized Field Sobriety Test.
- Several officers attended Subject Control Training and Autism Awareness training at Butler Tech.
- Sergeant Miller attended a 4-day less-lethal instructor training course allowing him to instruct on chemical munitions, less-lethal impact munitions, distraction devices, and OC aerosol devices.

## **TOPICS OF INTEREST:**

- Effective July 3, 2021, Sergeant McCroskey was reassigned to day shift road patrol supervisor, Sergeant Jamie Mays was reassigned to midnight shift road patrol supervisor, and Sergeant John VandeRyt was reassigned to Investigations Section supervisor.
- Officer Stebbins attended the Fairfield Rotary Club and discussed scams and frauds with those in attendance.
- Officer Singleton attended the Butler County Crisis Intervention Team committee meeting.
- Fatal crash in the intersection of SR4 Bypass and the eastbound SR129 entrance ramp involving a motorcyclist and a car. The motorcyclist was pronounced dead at the scene.
- Aggravated robbery and felonious assault on Saratoga Drive. Victim sustained non-life-threatening injuries during what he described as a drug deal.
- Alleged sexual assault occurred in the area at the dead-end of Lick Road after a suspicious vehicle was located in the creek. This case remains under investigation.
- A Butler County Grand Jury indicted Marc "Splash" Rycek on multiple counts of Complicity to Aggravated Robbery and other related charges for his role in the armed robbery at Speedway on Tylersville Road in May.
- Officers assisted the DVI Unit in the 2000-block of Parkamo Avenue which resulted in multiple drug arrests.
- Officer Stebbins worked with Kathy Becker in response to a complaint of a homeless encampment in the woods by Jones Auto. They continue to provide resources and work with those in need.

- Domestic violence incident in the 3200-block of Indian Meadows Drive. Both the step-father and juvenile were
  medically evaluated and booked into the BC Jail (adult) and BC JDC (juvenile).
- Injury crash on SR4 Bypass at Hamilton Mason Road. The at-fault driver ran a red light which caused the crash
   – northbound SR4 Bypass was shut down for approximately one hour and multiple people were transported to
   the hospital.
- Injury crash on Princeton Road near Jayfield Drive involving a juvenile on a bicycle and a truck. The juvenile sustained injuries and was transported to the hospital.
- Motor vehicle theft from the 3500-block of Saratoga. Victim believes car was unlocked at the time of the theft.
- Theft of a handgun from an unlocked vehicle in the 3400-block of Berrywood Court.
- Theft of a vehicle and trailer from the 4100-block of Tonya Trail.
- 13-year old runaway stole items valued over \$5000 from her family. Juvenile was located in Hamilton several hours later.
- A female filed a report that a male subject attempted to kidnap her by forcing her into a vehicle in the UDF parking lot on Tylersville Road. Investigation pending which includes if the alleged offense occurred.
- Officers transported a female to the Atrium Medical Center for a psychological evaluation following suicidal statements made while at the Social Security Administration Office on Winford Avenue. The child was removed by BC Children Services and turned over to a family friend.
- Domestic incident in the 2700-block of Tylersville Road when a son refused to clean his room per his parents' orders. He ended up stealing this father's truck and busted out the windows of the family camper. The son threatened physical harm to his dad and was arrested and charged with multiple offenses.
- Officers responded to a single-vehicle crash in the construction zone in the 2200-block of Princeton Road. The
  driver tried to drive through the construction area and became stuck and then passed out at the wheel. Officers
  towed the vehicle and arrested the driver for OVI, Failure to Control, and Driving under Suspension. The driver
  had a prior OVI arrest and refused tests.
- A vehicle was left at the gas pump at Speedway (Creekside Drive) for possibly a couple of hours. The driver later came out of the restroom and officers learned she had a warrant out of Hamilton and had a suspended driver's license. A consensual search revealed drugs and criminal charges are pending.
- Officers responded to Home Depot for a crash involving an intoxicated driver trying to leave the scene. The driver struck a retaining wall and utility box and then fled the scene on foot, but officers located him hiding under a shed at Bridgewater Church. He was booked in the BC Jail for OVI and Leaving the Scene.
- Officers responded to Speedway on Tylersville Road for a driver slumped over the steering wheel. The driver
  was found to have his 4-year-old child in the vehicle and submitted to field sobriety testing. The driver was
  found to be impaired and was arrested for OVI along with child endangerment.
- Officers responded to UDF on Tylersville Road for an unwanted person with two dogs tied to the outside of the vehicle. He was uncooperative with officers and refused to leave the property and told officers they would have to kill him before he would leave. He attempted to get into the vehicle and stated the officers will have to shoot him. They arrested him for criminal trespassing and obstructing official business and booked him into the BC Jail. The dogs were taken to the animal shelter and officers located two large knives in the car during the inventory process.
