TRAINING:

- The police department received provisional certification for body cameras by the Ohio Collaborative.
- Officers Green, Mitchell, and Sensel completed the 40-hour Butler County Crisis Intervention training.
- Officer Willis held an in-service training (refresher) course for all personnel on OVI Detection and Standardized Field Sobriety Test. Officer Willis went to SFTS Instructor training earlier in the year and is now teaching his fellow officers.
- All sworn personnel continue to complete annual firearms and less-lethal qualification as well as building searches and simunition training.
- New officers completed the 8-hour Patrol Rifle certification course.

TOPICS OF INTEREST:

- Officer Boyer attended the "Touch a Truck" event at Fairfield North Elementary School. The police department had a police car there and Officer Boyer also had the SWAT BearCat truck on display.
- Detectives served a search warrant at a residence on Wood Court related to a sex offense. Charges are pending.
- Armed robbery at Speedway located at 3450 Tylersville Road. A 16-year-old male held up the clerk at gunpoint before fleeing in a stolen car. The accomplice, and 18-year-old male, is being charged with complicity to aggravated robbery. The subjects robbed two other stores at gunpoint around the same timeframe and both subjects face possible charges for stealing cars the same day as the robberies.
- Emotionally disturbed person (EDP) at LA Fitness. The subject said he was looking for a gun to kill himself and voices in his head are telling him to fight police, take their guns, and kill them. Officers were able to de-escalate and transport him for an evaluation without further incident.
- Detectives/Officers testified at a 2-day jury trial against a defendant who is being tried for kidnapping, rape, felonious assault, and domestic violence. The jury returned guilty verdicts on the kidnapping and domestic violence charges and sentencing is scheduled for June 28th.

- Hamilton Mason Road and Morris Road for a vehicle into a pole. The pole was snapped in half which required
 officers to standby until public utilities could remove the pole. Officers later learned that the driver
 intentionally drove the vehicle into the pole and had also struck another vehicle just prior to this.
- 4000-block of Autumn Hill for a step-parent who was assaulted and injured by a step-child. The juvenile was charged with domestic violence.
- 3300-block of Bentbranch Drive for a female who had visible injuries from being assaulted. The male subject (offender) was arrested and charged with domestic violence and his parole officer violated his parole.
- Officers directed traffic on SR4 due to a large tree hanging over the southbound lanes. Part of SR4 was shut down for several hours and traffic was rerouted into the northbound lane until Duke Energy and Cincinnati Bell responded to cut the tree down. Units were on the traffic detail from 12:00 p.m. – 7:00 p.m.
- 7600-block of Wildbranch Road for a shots fired complaint. A suspicious vehicle occupied by four males was
 located and searched due to the odor of marijuana. Marijuana, a large amount of currency, and additional
 paraphernalia/evidence were seized, and charges filed. The sounds heard were actually fireworks.
- Tuley Road for a male attempting to gain entry into several houses. The male was found to have been walking
 on Tuley Road and trying to open doors as he passed them, startling families. Officers found him to be under
 the influence of an unknown narcotic, charged him with attempted burglary, and booked him into the BC Jail.
- Female shoplifter at Walmart attempted to throw away a small baggie of meth that she had pulled out of her bra and wrapped in a tissue. She was charged with multiple offenses and booked into the BC Jail.
- 6500-block of Elissa Drive for an intoxicated male who struck and bit his young son and assaulted and bit his cousin. The subject went back inside the house, locked his family outside, and barricaded the door. Officers surrounded the house and were able to order him outside and took him into custody without further incident. He was charged with domestic violence, assault, and child endangerment and booked into the BC Jail.
- Two-vehicle injury crash on SR129 near Hampshire Drive. The driver of a car was traveling at a high rate of speed and sideswiped another car. The reckless driver lost control and struck the concrete median and attempted to flee on foot before a passer-by was able to stop her until police arrived.
- 3300-block of Bentbranch for a stolen vehicle. The caller advised officers that her ex-boyfriend walked into her residence, removed keys from her purse, and stole her car. The vehicle was found in Cincinnati the next day.
- An officer observed a female riding a Walmart motorized cart in front of Kohls. The female was a missing juvenile out of Hamilton. She was transported to Liberty Children's Hospital for an evaluation.
- 1900-block of Shuler Avenue for an active fight. The caller advised dispatch that a person involved had a gun. Officers arrived and found an unconscious female on the ground. Witnesses advised they believe she consumed too much alcohol and may have alcohol poisoning. She was transported for a medical evaluation and the Sheriff's Office and Hamilton PD assisted due to some of the crowd acting aggressive toward officers.
- 6700-block of Lester Avenue for a male who was there violating a protection order and also broke the caller's phone and threatened to assault her. Officers arrested him for violating a protection order and domestic violence.
- 19 Penn Lane (Jones Auto) for two males trying to steal converters off junk cars. Officers could not locate the subjects and believe the employee and responding officers may have scared them off prior to stealing anything.
