- The Meadows of Indian Springs subdivision held their annual bike parade in the neighborhood. Members of the various township departments took part in the parade, and as always, the kids loved it.
- Several employees worked closely with the administrator on how to encourage employee health and wellness throughout the township. The committee distributed a presentation explaining the many benefits and shared the upcoming date for the annual Biometric Screening which is taking place on September 27th.
- It was another successful year at the Butler County Fair. Spec. Darrell Prewitt organized our agency displaying a police cruiser and worked the booth throughout the week, passing out promotional items and speaking with those who stopped and visited.
- Midnight shift officers arrested a male subject for his third OVI within 10 years after locating his crashed vehicle near SR4 and Creekside Drive.
- A day shift officer stopped a vehicle on Fairfax for a traffic violation. Upon approaching the vehicle, a resident who was outside told the officer that the driver threw a gun out of the window just prior to being pulled over. At that time, the car took off and fled the area. The officer recovered the handgun and was able to locate the abandoned vehicle later that day. Officers recovered a rifle with a modified silencer from inside the car as well as various drugs including possible fentanyl. This case remains under investigation.
- 7400-block of River Road for a fatal crash. A teenage driver struck a tractor-trailer head-on causing the fatal injuries; the truck driver sustained minor injuries. This crash remains under investigation.
- SR4 Bypass and Princeton Road for calls about a reckless driver. Officers located the vehicle in the Walmart parking lot and the driver was found to be under the influence of alcohol. The subject tested BAC .287 and he was charged with OVI.

- On July 22nd officers assisted the OVI Task Force checkpoint on Pleasant Avenue at Symmes Road. There were multiple vehicles redirected for various offenses including OVI, suspended license, and warrants.
- On July 28th detectives arrested a 19-year-old male for sex crimes he committed when he was a teenager. The three juvenile victims were all under 10-years-old at the time of the offenses.
- 3800-block of Canal Road for a single-vehicle motorcycle crash. The motorcycle operator lost control and was ejected from the bike, striking his head on the pavement. He was transported by air to UC (downtown) for serious injuries.
- Officers responded to Buffalo Wild Wings, Princeton Road, for a 60-year-old male who was at the restaurant to meet a 16-year-old girl he had been talking with on social media. However, the 16-year-old was a decoy profile created by a group who attempts to catch predators. The detectives took over the investigation for follow-up.
- A female was having a mental breakdown in her bedroom and barricaded herself inside with a knife. Officers communicated with her through her bedroom door and deescalated her enough to have her step outside. She continued making statements and committed other actions to which officers were able to transport her to a medical facility.
- Officers responded to Penn Lane for a male trespassing on the property. The suspect was found to have scratches on his body, a head injury, and appeared dehydrated and confused. The male could not offer a reasonable explanation of how he sustained the injuries and advised that it was likely a bobcat attack. He was taken into custody for several outstanding warrants and transported to the hospital for his injuries.
