## MISCELLANEOUS TOPICS OF INTEREST:

- There was a total of **82** arrests and **92** charges.
- Officer Scott Singleton, Officer Alexander Roush, and Officer Scyler Livelsburger took their oath of office at the January 8, 2020 Trustees Meeting. To date they completed several weeks of orientation, policy review, qualifications on equipment, and will start their field training at the beginning of February.
- One other candidate has successfully completed the hiring process and we anticipate he will take his oath of office in February. We continue to process candidates to fill the remaining open position.
- The new clearing barrel system arrived and is set up for use. This provides a safe method for clearing firearms.
- Tinch, Miller, and Boyer (Regional SWAT Team Members) responded out for simultaneous search warrants resulting in the recovery of drugs and guns.
- Investigations Section presented three cases for review to the BC Sexual Assault Task Force with two cases accepted to move forward with further investigation.
- Juvenile arrested for inducing panic (with a gun specification) for threats made toward Butler Tech.
- The juvenile arrested in December for the breaking and entering offense at Best Buy will be tried as an adult. His case will go before grand jury.
- Juvenile found guilty on two counts of Rape and two counts of Gross Sexual Imposition for sexually assaulting younger siblings. Sentencing pending at this time.
- Suspect arrested and charged with Robbery (F2) after threatening serious physical harm to Walmart loss prevention personnel when they stopped him during a theft offense.
- Walmart personnel observed a male subject purchasing items typically used to manufacture methamphetamine. Officers stopped the male subject who later confessed he bought the items to manufacture the drugs. A joint investigation with the Butler County Sheriff's Office BURN unit resulted in the service of a search warrant and successfully locating a meth lab in another jurisdiction. Agents arrested the subject's girlfriend on felony charges for her role in assembly to manufacture.
- Evening shift officer located an occupied vehicle at the dead-end of Princeton Road. Officers arrested a 22-year-old male who was engaged in sexual activity with a 14-year-old female.
- Officers arrested a male subject who was observed urinating on the soda machines near the store entrance. The subject also had stolen merchandise on his person as well as a hypodermic syringe. Subject booked into the jail for Public Indecency, Theft, and Possessing Drug Abuse Instruments.

- Officers responded to a male subject threatening self-harm. Officers found the male to be unresponsive and highly intoxicated. The subject came to and asked officers to shoot him and tried to reach for a knife in his nightstand. Officers detained the subject and transported him to the hospital for 72-hour hold.
- Officers responded to a juvenile threatening her grandmother with a knife. Officers arrested her for Domestic Violence and took her to Children’s hospital after she made threats of self-harm.
- Owner left vehicle running in the driveway of a residence on Tyler Point Drive. Unknown suspect stole the vehicle and it was recovered in Hamilton several days later. Investigation pending.
- Officers dispatched to a residence for a highly intoxicated male destroying the house. The male subject pulled a China cabinet full of dishes down on top of himself in an attempt to hurt himself. Officers transported him to the hospital for a 72-hour hold.
- There was an Attempted Robbery at Speedway on Creekside Drive. Officers were able to identify the subject and determined he needed to go to the hospital for an evaluation.
- Officers have responded to the area of Exeter//Belmont//Parkamo near Imlay for several “shots fired” calls during the month. Officers did a couple of nights of extra patrol where officers were sitting in the area and calls for “shots fired” stopped.
- Officers responded to Bethesda Butler and Coco’s Mexican Grill on Tylersville Road for a male Hispanic who was run over by a vehicle. The male advised subjects assaulted him and his group of friends in the parking lot of Coco’s around closing time. Victim was struck by his friend’s car who was trying to help get him away from the group assaulting him.
- Officers responded to several noise complaints concerning Coco’s on Saturday night. On Saturdays they convert the restaurant into a night club with a DJ. They have been told to turn the music down and this has been an ongoing problem. Officers have been called there for fights a few times over the last couple months. Chief Chabali and Captain Lanier went to the site and met with management/business owners to resolve the issue.
- Recovered stolen vehicle – midnight officers stopped a vehicle in the area of five-points and the driver was driving under suspension. Officers located three hypodermic needles in the vehicle and the license plates did not match the vehicle. The vehicle was stolen out of Hamilton the day prior.
- Day shift officers located a stolen car on Parrish Avenue and arrested the driver for Receiving Stolen Property and warrants. A large amount of a substance believed to be methamphetamine was located. Charges pending.
- SRO Davis assisted Cincinnati Christian School during their lockdown drill and provided additional insight and training.
