## MISCELLANEOUS TOPICS OF INTEREST:

- There was a total of **69** arrests and **84** charges.
- On March 29, 2020 Sergeant McCroskey, Officer Edens, Officer Robinson, and Officer Singleton attended the funeral procession for fallen Springdale Police Officer Kaia Grant. Officer Grant was killed in the line of duty on March 21<sup>st</sup> when a fleeing suspect struck her and her cruiser.
- The police department was awarded \$3,132.88 by the Ohio Attorney General's Office as part of the Ohio Law Enforcement Body Armor Program. This award covers 75% of the cost for five bulletproof vests for our officers.
- Sergeant McCroskey and Officer Gilbert provided in-service training which certified all sworn personnel on the new Taser 7.
- COVID-19 caused the police department to adjust some strategies in how it provides services to the community while maintaining the health interests of the employees as well as those they encounter. The police department is also complying with procedures issued by courts and the BC Prosecutor's Office and the challenges we all face in these challenging and unprecedented times.
- Officers conducted an operational plan for two houses and located and arrested a female who had an involuntary manslaughter warrant.
- Officers arrested a male subject for stealing his mother's check and then forging and cashing it. In addition to this, he is facing felony theft and felony domestic violence charges. He is currently in the Butler County Jail.
- Officers responded to Walmart for a report that a woman was tracking her daughters stolen cell phone. Officers located a suspect and were able to recover the phone, but not the stolen credit cards. Later that morning the same male subject and a female were arrested for a theft from the store. An hour later, after being released on the misdemeanor charges, the male and female were arrested at Kohl's for another theft incident.
- Officers located subjects driving a stolen vehicle on Walden Ponds. The driver bailed out of the car, fled on foot, and left the car in drive. One of the two passengers was able to get the vehicle stopped. The driver was subsequently identified. Several subjects charged for various traffic violations and crimes.
- Male victim reported an unknown person applied for a \$76,000 vehicle loan in his name.
- Officers responded to a business on Gilmore Road for a vehicle stolen by a terminated employee. The vehicle was recovered in the City of Hamilton and officers arrested the ex-employee and booked him into the BC Jail.
- Officers signed warrants on a male and female after learning they assaulted a victim on Lester Avenue.

- Officers responded to McCallister's for a subject known to have a felony warrant for aggravated burglary. The subject was located and taken into custody.
- Officers responded to Walmart for a theft suspect fleeing on a bicycle. Officers located the male subject and charged him with theft, obstructing official business, and drug abuse instruments.
- Officers responded to the area of Belmont Avenue and Parkamo Avenue for a 2-year-old struck by a vehicle. The child was transported to Liberty Children's for a possible broken leg.
- Officers responded to an address on Reigart Road for an EDP possibly under the influence of drugs. Officers located the subject in the front yard swinging a board and hallucinating. The subject was transported to the hospital for an evaluation.
- Officers responded to an address for two juveniles (10 and 12 yoa) who ran away following a problem that occurred at home. The fire department responded with the drone to assist in searching for the juveniles. Both juveniles were located (unharmd) after a two-hour search of the area.
- Officers responded to the area of Wildbranch Road for multiple calls of shots being fired in the area. Officers recovered 11 shell casings; however, no victims or suspects were identified.
- Officer arrested a male subject in the parking lot of CoCo's (Tylersville Road) for OVI and Open Container.
- A group of males in a BMW pulled into the Speedway lot (3350 Tylersville Road) and one of them stole a Chrysler 300 which was left running and unattended at the gas pump. The male driving the BMW was identified earlier in the shift when the group was acting suspicious at the Creekside Speedway. That male was arrested for obstructing official business, but the theft remains under investigation.
- Officers were called to suspicious activity in the area of Cheyenne Court. A gold Honda and a U-Haul truck were stopped. A male and female subject, both having felony warrants, fled on foot from the U-Haul. Officers apprehended the male as well as the driver of the Honda for driving under suspension and having a syringe.
- Officers stopped a vehicle for a violation on Tylersville//Tuley Road. The driver was intoxicated, arrested, and booked into jail. He had five prior OVI convictions at the time.
- Officers stopped a vehicle on James Place after violations were observed. The driver was found to be intoxicated and resisted arrest. The driver made suicidal threats during the booking process and was transported to the hospital for an evaluation.
- Officers responded to a call of a victim who had an alleged self-inflicted gunshot wound to the head and was still alive. The case remains under investigation.
- Officers responded to a vehicle that crashed into a ditch on Hamilton Cleves Road (SR128). The female driver was found to be intoxicated and arrested for OVI.
- Officers responded to SR4 near Headgates Road for a vehicle driving the wrong way on SR4. Officers located the vehicle and the driver was unresponsive. Officers had to break out the window to gain access to the driver who was having a diabetic emergency. She was transported to the hospital.
- Officers responded to an address on Osage for a group of young adults who slashed four tires, broke windows, and put several dents in a vehicle. The males fled on foot.
- Officers responded to an address on Fayette Drive on a couple occasions for a male stating people were trying to get into his house. It was determined the male was hallucinating as a result of combining prescription medications, marijuana, and alcohol. He was transported to the hospital for an evaluation.
